THE WEST GLAMORGAN COUNTY COUNCIL

(PENSCYNOR, NEATH)

(PROHIBITION OF WAITING) ORDER 1987

The West Glamorgan County Council in exercise of their powers under Sections 1 and 2 of the Road Traffic Regulation Act 1984 (which said Act of 1984 is hereinafter referred to as "the Act of 1984) and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby make the following Order.

- 1. This Order shall come into operation on the 30th day of November 1987 and may be cited as the West Glamorgan County Council (Penscynor, Neath) (Prohibition of Waiting) Order 1987.
- 2. Save as provided in Articles 3 and 4 to this Order no person shall, except on the direction of the Police Constable in uniform or of a traffic warden cause any vehicle to wait at any time on the sides or lengths of road specified in Schedule One to this Order or between 8.30 a.m. to 9.30 a.m., 12 noon to 1.30 p.m. and 3.00 p.m to 4.00 p.m. on any day except Saturday or Sunday on the sides or lengths of road specified in Schedule Two to this Order.
- Nothing in Article 2 to this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths or sides of roads specified therein for so long as may be necessary to enable:-
 - (a) a person to board or alight from a vehicle
 - (b) the vehicle if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations
 - (ii) the removal of any obstruction to traffic
 - (iii) the maintenance, improvement or reconstruction of the side of road, or
 - (iv) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewers or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus as defined in the Telecommunications Act 1984 or

- (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers and duties
- (d) the vehicle to be used for the purpose of delivery or collecting posted packets as defined in Section 87 of the Post Office Act 1953
- (e) the vehicle to wait at or near to any premises situated on or adjacent to any of the said sides or lengths of road for so long as such waiting by that vehicle is reasonably necessary in connection with any wedding or funeral or
- (f) the vehicle to be used for fire brigade, ambulance or police purposes or
- (g) stage carriage vehicles or omnibuses engaged in carrying out a local bus service as defined in the Transport Act 1985 when waiting at an authorised bus stop to set down or pick up passengers.
- (h) to omnibuses employed by or contracted to the West Glamorgan County Council for the conveyance of pupils to and from school.
- 4. Nothing in Article 2 to the Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled persons badge, and a parking disc (on which the driver or other person in charge of the vehicle has marked the time at which the period of waiting began) to wait on the sides or lengths of road referred to in the said Article for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same side of road).

6. In this Order:-

"disabled persons vehicle" has the same meaning as in the Local Authorities Traffic Orders (Exemptions for Disabled Persons) (England and Wales) (Amendment) Regulation 1975;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badged for Motor Vehicles) Regulations 1975:

"parking disc" means a disc issued by a Local Authority, complying with the requirements of the British Standard Specification for Parking Discs (B.S. No. 4631-1970), coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, and

"relevant position" means:-

- (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen;
- (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or nearside of the vehicle.
- 7. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 8. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.

SCHEDULE ONE.

Prohibition of Waiting - At Any Time

Penscynor (West Side).

From its junction with the entrance to Penscynor Wildlife Park southwards a distance of approximately 36 metres.

From its junction with the entrance to Penscynor Wildlife Park northwards a distance of approximately 104 metres.

Penscynor (East Side).

From its junction with the northern kerbline of The Pines northwards a distance of 15 metres.

From its junction with the southern kerbline of The Pines southwards (to the start of the layby) a distance of approximately 45 metres.

The Pines (Both Sides).

From its junction with the Eastern Kerbline of Penscynor eastwards a distance of approximately 10 metres.

SCHEDULE TWO.

Prohibition of Waiting 8.30 - 9.30 a.m., 12.00 - 1.30 p.m. and 3.00 - 4.00 p.m. Monday to Friday (except for school contract buses).

Penscynor (East Side in Layby).

From a point 45 metres south of the southern kerbline of The Pines southwards (to the entrance of the Primary School) a distance of approximately 55 metres.
