

NEATH PORT TALBOT COUNTY BOROUGH COUNCIL
(PENTWYN - BAGLAN (A48), PORT TALBOT)
(PROHIBITION OF WAITING) AND (AMENDMENT) ORDER 1997

The Neath Port Talbot County Borough Council in exercise of their powers under Sections 1, 2 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as the "Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

1. This Order shall come into operation on the 6th day of August 1997 and may be cited as the "Neath Port Talbot County Borough Council (Pentwyn - Baglan Road (A48), Port Talbot) (Prohibition of Waiting) and (Amendment) Order 1997"

2. (1) in this Order:-

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986;

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1982 as amended by the Disabled Persons (Badges for Motor Vehicles) (Amendment) Regulations 1991;

"parking disc" means a disc, issued by a Local Authority, complying with the requirements of the British Standard Specification for parking Discs (BS.4531 - 1970), coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, and

"relevant position" means:-

- (i) In the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen;
- (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front of nearside of the vehicle.

"public service vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981

"local service" shall have the same meaning as in Section 1 of the Transport Act 1985

3. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.

4. Save as provided in Article 5 or 6 of this Order no person shall, except upon the direction of a Police Constable in uniform or of a traffic warden, cause or permit any vehicle to wait at any time on the sides or lengths of road specified in the Schedule to this Order.
5. Nothing in Article 4 of this Order shall render it unlawful to cause or permit any vehicle to wait on the sides or lengths of road specified therein for so long as may be necessary to enable:-
 - (a) a person to board or alight from the vehicle;
 - (b) goods to be loaded on or unloaded from the vehicle;
 - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
 - (i) building, industrial or demolition operations;
 - (ii) the removal of any obstruction to traffic;
 - (iii) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in the Telecommunications Act 1984; or
 - (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
 - (e) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
 - (f) the vehicle to take in petrol, oil, water or air from any garage situated on or adjacent to the said length of road.
 - (g) public service vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers.
6. Nothing in Article 4 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the side of road referred to in the said Article for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same side of road).
7. The provisions of the West Glamorgan County Council (Access Road into Pentwyn Estate, Baglan, Port Talbot) (Revocation) and (Prohibition of Waiting and Loading and Unloading) Order 1989, made on 9 June 1989 are hereby amended by the addition of the words "post office or local authority vehicle" between the word "any" and before the words "public service vehicle" in Article 7 of the said Order.

8. The prohibitions and restrictions of this Order shall be in addition to and not in derogation of any other prohibitions or restrictions affecting the sides or lengths of road specified in the Schedule to this Order whether made in pursuance of the Act of 1984 or otherwise.

SCHEDULE.

Prohibition of Waiting At Any Time

PENTWYN - BAGLAN ROAD (WEST SIDE)

From a point directly opposite the southern kerblines of Smallwood Road northwards and southwards distances of approximately 28 metres and 43 metres respectively.

From a point 89 metres south of a point directly opposite the southern kerblines of Smallwood Road southwards a distance of approximately 106 metres.

PENTWYN - BAGLAN ROAD (EAST SIDE)

From its junction with the southern kerblines of Smallwood Road southwards to its junction with the western kerblines of Fernfield a distance of approximately 136 metres.

From its junction with the northern kerblines of Smallwood Road northwards a distance of approximately 10 metres.

From its junction with the eastern kerblines of Fernfield southwards including the Bus Layby a distance of approximately 47 metres.

SMALLWOOD ROAD (NORTH SIDE)

From its junction with the eastern kerblines of Pentwyn-Baglan Road eastwards a distance of approximately 10 metres.

SMALLWOOD ROAD (SOUTH SIDE)

From its junction with the eastern kerblines of Pentwyn-Baglan Road eastwards a distance of approximately 10m metres.

FERNFIELD (WEST SIDE)

From its junction with the eastern kerblines of Pentwyn-Baglan Road northwards a distance of approximately 5 metres.

FERNFIELD (EAST SIDE)

From its junction with the eastern kerblines of Pentwyn-Baglan Road northwards a distance of approximately 15 metres.
