#### (PONTARDAWE REGENERATION SCHEME - PHASE 2)

#### **ORDER 2013**

The Neath Port Talbot County Borough Council in exercise of their powers under Sections 1 and 2 and Part IV of Schedule 9 of the Road Traffic Act 1984 (hereinafter referred to as "the Act of 1984") and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order: -

- 1. This Order shall come into force on the 4th day of November 2013 and may be cited as the "Neath Port Talbot County Borough Council (Pontardawe Regeneration Scheme Phase 2) Order 2013".
- 2. (1) In this Order
  - "Disabled Person's Vehicle" has the same meaning as in The Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (Wales) Regulations 2000;
  - "Disabled Person's Badge" has the same meaning as in The Disabled Person's (Badges for Motor Vehicles) (Wales) (Amended) Regulations 2000;
  - "Parking Disc" means a parking disc issued by a Local Authority, capable of showing the quarter hour period during which a period of waiting begins;
  - "Relevant Position" has the same meaning as in The Disabled Persons (Badges for Motor Vehicles) (Wales) (Amended) Regulations 2000;
  - "Public Service Vehicle" shall have the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981 and "local service" shall have the same meaning as in Section 1 of the Transport Act 1985;
  - "Universal Providers" means those operators of postal services who are licensed to provide all or part of a Universal Postal Service under the provisions contained in the Postal Services Act 2000;
  - "Signed Bays" shall mean those bays designated for waiting, loading or unloading within the restricted zone which are identifiable by the appropriate signage;
  - "Mechanical Cleansing Vehicle" shall mean a street/drain cleaning vehicle owned by or contracted to the Neath Port Talbot County Council.

- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) The interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 3. The provisions of any existing orders (if any) relating to that length of Herbert Street as described in Schedule 1 of this Order are hereby revoked.
- 4. Save as provided in Articles 5, 15 and 17 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait, load or unload at any time on the lengths of sides of roads as set out in Schedule 2 of this Order.
- 5. The provisions or Article 4 shall not apply to vehicles which are waiting, loading or unloading in the Signed Bays provided
- 6. Save as provided in Articles 9, 15, 16 and 17 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait for more than 1 hour or to return within 2 hours to the same lengths of sides of roads on which that period of waiting began between the hours of 8.00am to 6.00pm on any day except Sunday on the lengths of sides of road set out in Schedule 3 of this Order.
- 7. Save as provided in Articles 9, 15, 16 and 17 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait for more than 2 hours or to return within 4 hours to the same length of side of road on which that period of waiting began between the hours of 8.00am and 6.00pm on any day except Sunday on the lengths of sides of road set out in Schedule 4 of this Order.
- 8. Save as provided in Articles 9, 15, 16 and 17 of this Order, no person except on the direction of a Police Constable in uniform or a Parking Attendant shall cause or permit any vehicle to wait for more than 1 hour or to return within 2 hours to the same length of side of road on which that period of waiting began between the hours of 10.00am and 6.00pm on any day except Sunday on the length of side of road set out in Schedule 5 of this Order.
- 9. Nothing in Articles 6, 7 and 8 shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge to wait on the lengths of sides of roads referred to in the said Articles.
- 10. Save as provided in Articles 11, 15 and 17 of this Order no person shall cause or permit any vehicle (including a Disabled Persons Vehicle) to wait, load or unload between the hours of 8.00am to 10.00am on any day except Sunday on the length of side of road as set out in Schedule 6 of this Order.

- 11. The provisions contained in Article 10 of this Order shall not apply to Goods Vehicles which are being loaded or unloaded.
- 12. Save as provided in Article 13 of this Order no person shall cause or permit any vehicle to proceed along the length of road set out in Schedule 7 of this Order other than in the direction specified therein.
- 13. Nothing in Article 12 of this Order shall apply to a Mechanical Cleansing Vehicle whilst engaged in any street/drain cleaning operations on behalf of the Neath Port Talbot County Borough Council.
- 14. No person shall cause or permit any vehicle to enter those roads specified in Schedule 8 of this Order at the points set out in that Schedule.
- 15. Nothing in Articles 4, 6, 7, 8 and 10 of this Order shall render it unlawful to cause or permit any vehicle to wait on the lengths of sides of roads specified therein for so long as may be necessary to enable: -
  - (A) A person to board or alight from a vehicle;
  - (B) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely: -
    - (i) Building, industrial or demolition operations;
    - (ii) The removal of any obstruction to traffic;
    - (iii) The laying, erection, alteration or repair in or on land adjacent to the said lengths of sides of roads of any sewer or any main pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus defined in the Telecommunications Act 1984;
  - (C) The vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a Local Authority or a Water Authority in pursuance of statutory powers or duties;
  - (D) The vehicle to be used by a Universal Service Provider for the purpose of delivering or collecting postal packets;
  - (E) Public Service Vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses;
  - (F) The vehicle to take in petrol, oil water or air from any garage situated on or adjacent to the said lengths of roads.

- 16. Nothing in Articles 6, 7 and 8 of this Order shall render it unlawful to cause or permit any vehicle to wait on the length of sides of roads specified therein for so long as may be necessary to enable goods to be loaded or unloaded from the vehicle.
- 17. The prohibitions imposed by Articles 4, 6, 7, 8 and 10 of this Order shall not apply to Police, Fire, Ambulance or other Emergency Service vehicles or to Local Authority vehicles when in pursuance of statutory duties or powers.

### **SCHEDULES**

### Schedule 1 - Revocations

### 1.1 Herbert Street, Pontardawe

To revoke all orders (if any) relating to Herbert Street from a point approximately 65 metres south east of its junction with Holly Street for a distance of approximately 127 metres in a south easterly direction.

# <u>Schedule 2 – Restricted Zone, No Waiting, Loading or Unloading At Any Time, Except in Signed Bays</u>

2.1 Herbert Street, Pontardawe

From a point approximately 65 metres south east of its junction with Holly Street for a distance of approximately 127 metres in a south westerly direction.

# <u>Schedule 3 – Waiting Limited to 1 Hour, No Return Within 2 Hours, 8.00am to 6.00pm, Monday to Saturday</u>

3.1 Herbert Street, Pontardawe (South West Side)

From a point approximately 65 metres south east of its junction with Holly Street for a distance of approximately 15 metres in a south easterly direction.

3.2 Herbert Street, Pontardawe (South West Side)

From a point approximately 118 metres south east of its junction with Holly Street for a distance of approximately 25 metres in a south easterly direction.

3.3 Herbert Street, Pontardawe (North East Side)

From a point approximately 65 metrs south east of its junction with Holly Street for a distance of approximately 46 metres in a south easterly direction.

## Schedule 4 – Waiting Limited to 2 Hours, No Return Within 4 Hours, 8.00am to 6.00pm, Monday to Saturday

4.1 Herbert Street, Pontardawe (North East Side)

From a point approximately 118 metres south east of its junction with Holly Street for a distance of approximately 25 metres in a south easterly direction.

# <u>Schedule 5 – Waiting Limited to 1 Hour, No Return Within 2 Hours, 10.00am to 6.00pm, Monday to Saturday</u>

5.1 Herbert Street, Pontardawe (South West Side)

From a point approximately 80 metres south east of its junction with Holly Street for a distance of approximately 12 metres in a south easterly direction.

## <u>Schedule 6 – Goods Vehicles Loading Only, 8.00am to 10.00am, Monday to Saturday</u>

### 6.1 Herbert Street, Pontardawe (South West Side)

From a point approximately 80 metres south east of its junction with Holly Street for a distance of approximately 12 metres in a south easterly direction.

### Schedule 7 - One Way Order

### 7.1 Herbert Street, Pontardawe

From a point approximately 65 metres south east of its junction with Holly Street for a distance of approximately 200 metres in a south easterly then north easterly direction.

### Schedule 8 – No Entry Order

### 8.1 Herbert Street, Pontardawe

At a point approximately 75 metres south west of its junction with Tawe Terrace, vehicles are prohibited from moving in a westerly direction.
