## (SCHOOLS) (RESTRICTIONS) (NO. 3)

#### **ORDER 1991**

The County Council of West Glamorgan (hereinafter referred to as "the County Council") in pursuance of its powers as contained in Sections 1 and 2 of the Road Traffic Regulation Act 1984 (hereinafter called "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order:-

- 1. This Order may be cited as the West Glamorgan County Council (Schools) (Restrictions) (No. 3) Order 1991 and shall come into operation on 5th day of July 1991.
- 2. In this Order:-

"disabled person's vehicle" has the same meaning as in the Local Authorities' Traffic Orders (Exemptions for Disabled Persons) (England and Wales) Regulations 1986.

"disabled person's badge" has the same meaning as in the Disabled Persons (Badges for Motor Vehicles) Regulations 1982.

"parking disc" means a disc issued by a Local Authority, complying with the requirements of the British Standard Specification for parking discs (B.S. 4631 - 1970) coloured orange, and capable of showing the quarter hour period during which a period of waiting begins, and

"relevant position" means:-

- (i) in the case of a vehicle fitted with a front windscreen, the badge is exhibited thereon with the obverse side facing forwards on the nearside of and immediately behind the windscreen;
- (ii) in the case of a vehicle not fitted with a front windscreen, the badge is exhibited in a conspicuous position on the front or nearside of the vehicle.

"public service vehicle" has the same meaning as in Section 1 of the Public Passenger Vehicles Act 1981.

"local service" has the same meaning as in Section 1 of the Transport Act 1985.

"school bus" means a vehicle constructed or adapted to carry more than 12 passengers and being used to convey school children to and from school.

- 4. The provisions of the West Glamorgan County Council (Schools) (Restrictions) Order 1989 and all other orders whether made under the Act of 1984 or its predecessors are hereby revoked in so far as they relate to the road or side of road and the restrictions placed thereon as specified in Schedule 1 to this Order.
- Save as provided in Articles 6 and 7 of this Order no person shall except on the direction of a Police Constable in Uniform or of a traffic warden cause or permit any vehicle:-
  - (i) to wait at any time on the sides or lengths of road as set out in Schedule 2 to this Order.
  - (ii) to wait at any time between 8.00 a.m. and 6.00 p.m. on any day except Saturday or Sunday on the sides or lengths of road as set out in Schedule 3 to this Order.
  - (iii) to wait at any time between 8.00 a.m. and 4.00 p.m. on any day except Saturday or Sunday on the sides or lengths of road as set out in Schedule 4 to this Order.
  - (iv) to wait between the hours of 8.15 a.m. and 9.15 a.m., 11.45 a.m. and 1.00 p.m. or between 3.00 p.m. and 4.00 p.m. on any day except Saturday or Sunday on the sides or lengths of road as set out in Schedule 5 to this Order.
  - (v) to wait between the hours of 8.30 a.m. and 9.30 a.m. or 3.00 p.m. and 4.00 p.m. on any day except Saturday or Sunday on the sides or lengths of road as set out in Schedule 6 to this Order.
  - (vi) to wait between the hours of 8.15 a.m. and 9.15 a.m., 3.15 p.m. and 4.15 p.m. on any day except Saturday or Sunday on the sides or lengths of road as set out in Schedule 7 to this Order.
- Nothing in Article 5 of this Order shall render it unlawful to cause or permit any vehicle to wait on the sides or lengths of road specified therein for so long as may be necessary to enable:-
  - (a) a person to board or alight from the vehicle;
  - (b) goods to be loaded on or unloaded from the vehicle;
  - (c) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any of the following operations, namely:-
    - (i) building, industrial or demolition operations;

- (ii) the removal of any obstruction to traffic;
- (iii) the laying, erection, alteration or repair in or on land adjacent to the said side of road of any sewer or of any main, pipe, or apparatus for the supply of gas, water or electricity or of any telecommunications apparatus defined in the Telecommunications Act 1984: or
- (d) the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in the service of a local authority or of a water authority in pursuance of statutory powers or duties;
- (e) the vehicle to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
- (f) public service vehicles operating a local service when waiting at an authorised bus stop to set down or pick up passengers, or to school buses.
- 7. Nothing in Article 5 of this Order shall render it unlawful to cause or permit a disabled person's vehicle which displays in the relevant position a disabled person's badge, and a parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait on the side of road referred to in the said Article for a period not exceeding 2 hours (not being a period separated by an interval of less than 1 hour from a previous period of waiting by the same vehicle on the same side of road).
- 8. The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any other prohibition or restriction whether imposed under the Act of 1984 or otherwise.

## SCHEDULE 1.

REVOCATION OF NO WAITING AT ANY TIME ORDER.

Belgrave Road, Gorseinon (South Side)

From a point approximately 20 metres east of the eastern kerbline of Penuel Close in an easterly direction a distance of approximately 20 metres.

#### NO WAITING AT ANY TIME ORDER

## Parkhill Terrace, Treboeth (East Side)

From a point in line with the northern kerbline of Parkhill Road for a distance of 5 metres in a northerly direction.

From a point in line with the southern kerbline of Parkhill Road in a southerly direction a distance of 5 metres.

## Parkhill Road, Treboeth (Both Sides)

From a point in line with the eastern kerbline of Parkhill Terrace in an easterly direction a distance of approximately 10 metres.

## Parkhill Road, Treboeth (North Side)

From a point in line with the western kerbline of Gelert Street in a westerly direction a distance of approximately 10 metres.

From a point in line with the eastern kerbline of Gelert Street in an easterly direction a distance of approximately 10 metres.

## Parkhill Road, Treboeth (South Side)

From a point in line with the western kerbline of Lloyd Road in a westerly direction a distance of approximately 10 metres.

From a point in line with the eastern kerbline of Lloyd Road in an easterly direction a distance of approximately 10 metres.

#### Gelert Street, Treboeth (Both Sides)

From a point in line with the northern kerbline of Parkhill Road in a northerly direction a distance of 5 metres.

#### Lloyd Road, Treboeth (Both Sides)

From a point in line with the southern kerbline of Parkhill Road in a southerly direction a distance of 5 metres.

# Brynamman Road, Brynamman (South East Side)

From a point in line with the south western kerbline of Barry Road in a south westerly direction a distance of approximately 15 metres.

From a point in line with the north eastern kerbline of Barry . Road in a north easterly direction a distance of approximately 15 metres.

# Barry Road, Brynamman (Both Sides)

From a point in line with the south eastern kerbline of Brynamman Road in a south easterly direction a distance of approximately 5 metres.

# Croft Street, Dyfatty (South Side)

From a point 10 metres west of the western kerbline of High Street in a westerly direction a distance of approximately 70 metres.

From a point in line with the western kerbline of Trewyddfa Road in a westerly direction a distance of approximately 30 metres.

#### Clordir Road, Pontlliw (North Side)

From a point approximately 55 metres east of the eastern kerbline of Bryntirion Road in an easterly direction a distance of approximately 65 metres.

Bryn Road, Cwmllynfell (North West Side)

From a point approximately 90 metres south west of the junction with Gwilym Road (A4068) in a south westerly direction a distance of approximately 25 metres.
