(STATION ROAD SERVICE AREA ZONE, PORT TALBOT)
AND (REVOCATION)

ORDER 2008

The Neath Port Talbot County Borough Council in pursuance of its powers as contained in Sections 1, 2, 32, 33, 45, 46, 53 and 61 and Part IV of Schedule 9 of the Road Traffic Regulation Act of 1984 (hereinafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984 hereby make the following Order: -

1. This Order may be cited as the Neath Port Talbot County Borough Council (Station Road Service Area Zone, Port Talbot) and (Revocation) Order 2008 and shall come into force on the 8th day of October 2008.
2. (1) In this Order: -
 - "Commercial Delivery Vehicles" shall mean those vehicles which are being used for the loading or unloading of commercial goods at those premises adjacent to the Service Area Zone;
 - "Service Area Zone" shall mean that area of land which is shown edged red on the plan in this Order;
 - "Parking Bays" shall mean those 18 areas of land shown as white boxes numbered 1 to 18 respectively within the Service Area Zone on the plan in this Order;
 - "Permit" means a permit issued by the Council for a period of up to twelve months to a person who has satisfied the Council as being entitled to the issue of a permit in accordance with the Council's policy as may be determined from time to time.
- (2) Except where otherwise stated, any reference in this Order to a numbered Article or Schedule is a reference to the Article or Schedule bearing that number in this Order.
- (3) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. Save as provided in Articles 4 and 5 of this Order no person except on the direction of a Police Constable in uniform or of a Parking Attendant shall cause or permit any vehicle to park in the Service Area Zone.

4. The provisions of Article 3 shall not apply to Commercial Vehicles which are engaged in loading or unloading on that area of the Zone which is marked with yellow cross hatched markings and shown as a yellow cross hatched area on the plan in this Order.
5. The provisions of Article 3 shall not apply to vehicles which are parked in any one of the 18 designated Parking Bays only within the Service Area Zone provided that they are displaying a valid permit.
6. The provisions of Articles 9, 10 and 11 and Schedule 5 of the Neath Port Talbot County Borough Council (Rear Lanes and Car Parks Access Road, Station Road, Port Talbot) (Loading Only) (No Waiting, Loading or Unloading) (No Stopping At Any Time, Except Taxis) (Permit Holders Only Zone) (No Waiting, No Loading Except School Contract Buses) and (Revocation) Order 2000 are hereby revoked.
