

RESTRICTION OF WAITING, LOADING AND UNLOADING

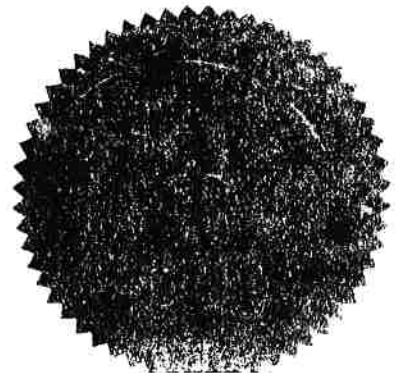
(AMENDMENT NO. 2) ORDER, 1977

Superseded.

The West Glamorgan County Council in exercise of their powers under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part IX of the Transport Act, 1968, Schedule 19 to the Local Government Act, 1972 and Schedule 6 of the Road Traffic Act, 1974 (which said Act of 1967 as so amended is hereinafter referred to as "the Act of 1967") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Section 84C (1) of the Act of 1967, hereby make the following Order:-

1. This Order shall come into operation on the 20th day of May, 1977, and may be cited as the "West Glamorgan County Council (Various Streets, Neath)(Prohibition and Restriction of Waiting, Loading and Unloading) (Amendment No.2) Order, 1977"
2. "The West Glamorgan County Council (Various Streets, Neath) (Prohibition and Restriction of Waiting, Loading and Unloading) Order, 1976" made on the 17th March, 1976 and hereinafter referred to as "the Principal Order" is hereby amended by the addition or the deletion of the following lengths or sides of roads:-
 - (i) that length of Windsor Road (West Side) from a point 20 metres south from the pelican crossing to a point 15 metres north from the junction with The Ropewalk shall be deleted from Schedule 2 and added to Schedule 3 to the Principal Order;
 - (ii) that length of Alfred Street (North Side) from a point outside the eastern end of No.17 for a distance of 20 metres in an easterly direction (i.e. the 'bus stand') shall be added to Schedule 1 to the Principal Order;
 - (iii) that length of The Parade (Side Road) on its south east side, from a point 15 metres south west of the junction with The Parade (Main Road) for a distance of 19 metres in a south westerly direction shall be deleted from Schedule 1 and added to Schedule 4 to the Principal Order;
 - (iv) that length of The Ropewalk (West of Windsor Road) - fronting Ropewalk Terrace (North Side) from Dark Arch to the eastern boundary of No. 1 Ropewalk Terrace, shall be deleted from Schedule 3 to the Principal Order and added to Schedule 4 thereof.
3. The Interpretation Act, 1889, shall apply for interpretation of this Order as it applies for the interpretation of an Act of Parliament.
