The West Glamorgan County Council in exercise of their powers under Section 1 (1), (2) and (3) of the Road Traffic Regulation Act, 1967, as amended by Part 1X of the Transport Act, 1968, and Schedule 19 to the Local Government Act, 1972, and of all other powers them enabling in that behalf, and after consultation with the Chief Officer of Police in accordance with Section 84C(1) of the said Act of 1967, hereby make the following Order:-

- 1. Save as provided in Article 2 of this Order, no person, shall except upon the direction or with the permission of a police constable in uniform or of a traffic warden cause or permit any vehicle to wait at any time on the sides of roads or in the lengths of road specified in the Schedule to this Order;
- 2. Nothing in Article 1 of this Order shall prevent any person from causing or permitting a vehicle to wait in the lengths of roads referred to in that Article for so long as may be necessary:-
 - (i) to enable a person to board or alight from the vehicle;
 - (ii) to enable goods to be loaded onto or unloaded from the vehicle;
 - (iii) to enable the vehicle if it is in the service or employed by the Post Office to be used for the purpose of delivering or collecting postal packets as defined in Section 87 of the Post Office Act, 1953;
 - (iv) to enable the vehicle, if it cannot conveniently be used for such purpose in any other road, to be used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance, improvement or reconstruction of the road, the side of the road or the length of road so referred to or the laying, ercction, alteration or repair in or near the said road, the said side of road or the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity, or of any telegraphic line, as defined in the Telegraph Act, 1878, or to enable the vehicle, if it cannot conveniently be used for such purpose in any other road to be used in pursuance of statutory powers or duties;
 - (v) to enable the vehicle to take in petrol, oil, water or sir from any garage situated on or adjacent to the said road, the said side of road or the said length of road, or
 - (vi) to enable any vehicle owned by a funeral director or owner of funeral vehicles to be used as part of a funeral cortege or otherwise in connection with a funeral;
- The restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act, 1967, as amended as aforesaid or by or under any other enactment.
- 4. The Interpretation Act, 1839, shall apply for the interpretation of this Order, as it applies for the interpretation of an Act of Parliament.
