Schedule 1	Restricted Roads
------------	------------------

The Council of the City of Newcastle upon Tyne (hereinafter referred to as “the Council”) in exercise of its powers under Sections 1(1), 2(1) to (3), 4(2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) and of all other powers enabling it in that behalf, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

PART I

GENERAL

Commencement and Citation

1. This Order shall come into operation on 25th February 2009, and may be cited as the City of Newcastle upon Tyne (City Centre Controlled Parking Zone) Restriction of Waiting Order 2009.

Interpretation

2. (1) In this Order the following expressions have the meanings hereby respectively assigned to them:-

“the Act” means the Road Traffic Regulation Act 1984

“the 1994 Act” means the Vehicle Excise and Registration Act 1994

“the Badges Regulations” means the Disabled Persons (Badges for Motor Vehicles) (England) Regulations 2000

“the Exemption Regulations” means the Local Authorities’ Traffic Orders (Exemption for Disabled Persons) (England) Regulations 2000

“the 1998 Regulations” means the Local Authorities (Transport Charges) Regulations 1998

“authorised activity” means:

- (i) furniture removal to or from a property in the restricted street;
- (ii) loading bulky or heavy items onto, or unloading bulky or heavy items from a goods vehicle in circumstances where it would be impossible or impracticable to carry the item from the nearest parking place; or
- (iii) use as a bridal or attendant’s vehicle at a wedding; or
- (iv) any other activity approved by the Council

“civil enforcement officer” means a person authorised by the Council pursuant to section 76 of the Traffic Management Act 2004

“the Council” means the Council of the City of Newcastle upon Tyne

“disabled person’s badge” has the same meaning as in the Badges Regulations

“dispensation certificate” means a certificate issued under section 4(2) of the Act in accordance with the procedure set out in Article 6

“parking disc” has the same meaning as in the Exemption Regulations

“penalty charge” means a charge set by the Council pursuant to the provisions of section 77 and Schedule 9 of the Traffic Management Act 2004 and any regulations made thereunder and in accordance with any guidance given by the Secretary of State

“penalty charge notice” means a notice issued by a civil enforcement officer pursuant to the provisions of section 78 of the Traffic Management Act 2004 and any regulations made thereunder

“postal packet” has the same meaning as in section 125 of the Postal Services Act 2000

“public service vehicle” has the same meaning as in the Traffic Signs Regulations and General Directions 2002

“registration mark” means a mark indicating the registered number of the vehicle assigned to the vehicle by Secretary of State pursuant to section 23 of the 1994 Act upon its registration under section 21 of the 1994 Act

“relevant information” means:

- (i) The registration mark of the vehicle or company name in respect of which the dispensation certificate has been issued;
- (ii) The start date and expiry date of the dispensation certificate;
- (iii) The restricted road for which the dispensation certificate has been issued and in which the vehicle may wait;
- (iv) The authorised activity for which the vehicle is permitted to wait in the restricted road;
- (v) An authentication that the dispensation certificate has been issued by the Council; and
- (vi) A dispensation certificate number

“relevant position” has the same meaning as in the Exemption Regulations

“specified position” means a prominent and conspicuous position on the vehicle so that the relevant information is clearly visible from outside the vehicle

“statutory undertaker” has the same meaning as defined in section 48 of the New Roads and Street Works Act 1991

“valid dispensation certificate” means a dispensation certificate:

- (i) Issued in respect of the vehicle on which it is displayed in the relevant position;
- (ii) Which states on its face that it is valid on the date when the vehicle is waiting in the restricted road;
- (iii) Which has been issued in respect of the restricted road in which the vehicle is waiting;
- (iv) Which has been issued in respect of the authorised activity in which the vehicle is involved while it is waiting in the restricted road;
- (iv) Which is authenticated as having been issued by the Council; and
- (v) Which contains a dispensation certificate number.

- (2) Any reference in this Order to any enactment or to any regulations shall be construed as a reference to that enactment or those regulations as amended by any subsequent enactment or regulations.

Revocation

3. The following Orders are hereby revoked:-

- (i) The City of Newcastle upon Tyne (Restriction of Waiting) Order 2001
- (ii) The City of Newcastle upon Tyne (Laing Square Area) Traffic Regulation Order 2002
- (iii) The City of Newcastle upon Tyne (Neville Street Area) Traffic Regulation Order 2003

PART II

WAITING RESTRICTIONS

Restriction of Waiting of Vehicles in Restricted Roads

4. (1) Save as provided in Article 5 of this Order no person shall, except in the case of an emergency upon the direction or with the permission of a uniformed police officer cause or permit any vehicle to wait at any time in any of the roads or parts of roads described in Schedule 1 to this Order

PROVIDED THAT the provisions of this paragraph shall not apply to any part of a road designated as a parking place.

- (2) Any road or part of a road in which waiting is restricted under paragraph (1) of this Article is hereinafter called a "restricted road".
- (3) Reference to a restricted road in Column 1 of Schedule 1 shall be a reference to both sides of the road and the whole length of the road (footways and verges included) except as may be otherwise specified in Column 2 of Schedule 1.

Exemptions from Waiting Restrictions

5 (1) Nothing in Article 4 of this Order shall prevent any person from causing or permitting a vehicle to wait in any restricted road for so long as may be necessary:-

- (a) to enable a person to board or alight from the vehicle.
- (b) to enable the vehicle, if it cannot conveniently be used for such purpose in any unrestricted road, to be used in connection with:
 - (i) A funeral, as a hearse or the vehicle of a chief mourner;
 - (ii) The removal of any obstruction to traffic in any restricted road;
 - (iii) The maintenance, improvement or reconstruction of any restricted road;
 - (iv) Any statutory undertaker or their authorised agent or local authority carrying out its duties on the highway; or

- (v) Any excavation or demolition works to properties fronting onto the restricted road..
 - (c) to enable goods to be:
 - (i) Loaded onto the vehicle from premises situated in the restricted road; or
 - (ii) Unloaded from the vehicle to premises situated in the restricted road.
 - (d) if the vehicle is a vehicle used by emergency services for an essential matter and in pursuance of statutory powers or duties.
 - (e) if the vehicle is waiting because the driver is being prevented from proceeding by circumstances beyond his control or if it is necessary to wait in order to avoid accident.
 - (f) if the vehicle is waiting in a restricted road and is at that time engaged in the collection or delivery of postal packets to or from premises or posting boxes adjacent to that restricted road and the vehicle is waiting only so long as is necessary to enable the delivery or collection of those postal packets.
 - (g) if the vehicle is waiting in a restricted road and is at that time engaged in connection with the servicing of a telephone kiosk on that restricted street, and the vehicle is waiting only for so long as is necessary to enable the telephone kiosk to be serviced.
 - (h) if the vehicle is a public service vehicle operating a local service waiting at a bus stop to set down and/or pick up passengers.
- (2) Nothing in Article 4 of this Order shall render it a contravention of this Order to cause or permit any vehicle which displays in the relevant position a valid disabled person's badge, and a valid parking disc (on which the driver, or other person in charge of the vehicle, has marked the time at which the period of waiting began) to wait in any of the restricted roads referred to in the said Schedule to this Order, for a period not exceeding three hours (not being a period separated by an interval of less than one hour from a previous period of waiting by the same vehicle in the same length of road on the same day)

PROVIDED THAT such period of waiting shall not be within a period during which the loading or unloading of vehicles is prohibited or restricted

PROVIDED THAT such badge and parking disc are being used in accordance with any regulations made for their use as may be in force from time to time.

- (3) Nothing in Article 4 of this Order shall render it a contravention of this Order to cause or permit any vehicle which displays, in the specified position, a valid dispensation certificate to wait in the restricted road specified on that dispensation certificate.

- (4) Notwithstanding anything in the preceding provisions of this Article, the driver of a vehicle shall move the vehicle on the instruction of a police constable in uniform whenever it may be reasonably necessary to do so for the purpose of preventing obstruction.

Issue of Dispensation Certificates

6. (1) Any person may at any time make an application to the Council for a dispensation certificate.
- (2) An application for a dispensation certificate shall:
 - (a) Be made in writing on a form issued by the Council which is returned to the Council completed in every material respect.
 - (b) Without prejudice to sub-paragraph (a) shall contain the following information:
 - (i) The name of the person making the application and their address;
 - (ii) The property in the restricted road in respect of which a dispensation certificate is sought;
 - (iii) The make, model, colour and registration mark of the vehicle or the company name in respect of which the dispensation certificate is sought;
 - (iv) The dates for which the dispensation certificate is sought; and
 - (iv) The purpose for which the dispensation certificate is sought.
 - (c) Include a remittance for any charge requested by the Council pursuant to the 1998 Regulations.
- (3) Without prejudice to paragraph (2) the Council may at any time require any person who has made an application for a dispensation certificate to produce to the Council such evidence in respect of the application as the Council may reasonably require to verify any of the particulars or information given in the application.
- (4) The Council may issue a dispensation certificate in respect of an authorised activity, whether pursuant to an application made in accordance with paragraphs (1) and (2) of this Article, or otherwise.
- (5) A dispensation certificate issued pursuant to paragraph (4) shall be issued in writing and shall contain the relevant information.
- (6) The Council may cancel a dispensation certificate by service of a notice in writing on the person to whom the dispensation certificate was issued and, upon the service of such notice (or upon such other time or date as may be specified in the said notice), the dispensation certificate shall cease to be a valid dispensation certificate.

Evidence Provisions

- 7. The particulars given in any penalty charge notice issued as a result of a contravention of any the Articles of this Order shall be treated as evidence of those particulars in any proceedings arising as a result of the issue of that penalty charge notice.

Savings

- 8. The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act, or by or under any other enactment.
