

THE NORTH LINCOLNSHIRE BOROUGH COUNCIL
(OFF-STREET PARKING PLACES)
(CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2010
(VARIOUS CAR PARKS) (AMENDMENT NO 6) ORDER 2015

North Lincolnshire Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

- 1 The North Lincolnshire Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2010 shall be amended to the extent described in the Schedule to this Order.
- 2 This Order shall come into operation on the 24th July 2015 and may be cited as The North Lincolnshire Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2010 (Various Car Parks No 6) (Amendment) Order 2015.

SCHEDULE

To amend Clause 2 as follows insofar as it relates to the following interpretations:

"daily charge" means the charge (if any) imposed by the Council for parking in a parking place on any one day and for a specified period of time as is identified in the scale of charges specified by notice on site;

"pay and display ticket" means a ticket issued by a ticket machine located in the parking place in which the vehicle has been parked or issued by a person nominated by the Council on payment of a charge (if any) and valid for a parking period as advertised at that parking place;

"ticket machine" means an apparatus of a type and design approved by the appropriate Minister for the purpose of the 1984 Act, being apparatus designed to indicate the time by a clock and to issue parking tickets which show that a payment (if any) has been made of an amount or for a period specified thereon and which specify the date and, either the time of such payment (if any), or the expiry time of the parking period for which payment (if any) has been made;

To introduce a new interpretation under Clause 2 as follows - "free parking period" means a parking period for which no payment is required and as indicated on the individual car park tariff board(s);

To amend clause 7 (Designation) as follows - Each area of land or building specified by name in the Schedules may be used, subject to the provisions of this Order, as a place to park vehicles of such classes, in such positions, on such days, during such hours, for such period and on payment of such charges (if any) as are specified in the schedules or advertised at each parking place.

To amend clause 23 (Means of Payment) as follows - The charges (if any) referred to in the preceding Article shall be payable in the manner as advertised at that parking place.

To amend clause 24 (Pay and display parking places as follows - The person in charge of a vehicle, upon parking the vehicle in a parking place shall immediately arrange for the purchase of a pay and display ticket (or the obtaining of one for a free parking period) from a ticket machine situated at that parking place at the level of charge (if any) and for the period required in accordance with the scale of daily charges as advertised at that parking place.

To amend clause 28 (Expiry of parking period) as follows - The expiry of the period for which the appropriate charge has been paid shall be (i) where a pay and display ticket has been obtained/purchased, when the time shown on the clock of the issuing ticket machine is later than the expiry time shown on the pay and display ticket displayed.

To amend clause 29 (No pay and display ticket displayed) as follows - If at any time while a vehicle is parked in a parking-place no pay and display ticket is displayed on that vehicle in the relevant position and in accordance with the provisions of this order, it shall be deemed that a ticket has not been obtained/that the charge has not been paid.

To delete the following clauses (37-40 inclusive), which relate to the Parishes Multi-Storey Parking Place:

37 - The driver of a vehicle shall obtain a ticket from the entry barrier point at the parking place and shall pay the parking charge in accordance with the scale of charges as advertised at the parking place by the insertion of the ticket and appropriate payment at a pay station prior to leaving the parking place by inserting the ticket (validated as to payment) into the exit barrier point.

38 - If the pay stations are out of order the parking charge shall be paid to a parking attendant.

39 - If the ticket is lost, damaged or defaced and cannot be used for payment of the parking charge the daily parking charge payable shall be as for a stay for a period of more than four hours.

40 - Customers or patrons of the multiplex cinema shall be exempt from paying the parking charge where use of the parking place commences after 2pm on any given day and does not exceed a continuous period of three hours by such customers or patrons inserting the ticket obtained as in clause 37 above and duly validated by the cinema at a pay station prior to leaving the parking place as described above. Where the use commences after 2pm on any given day but exceeds three hours the balance of the stay will be paid for as set out above.

To include in Clause 41 (Exemption from daily charge) a new clause such that no daily charge shall be payable in respect of (iv) where there is a 'free parking period' offered and the vehicle is displaying a valid 'free ticket'.

To amend the Schedule to the 2013 Consolidation Order as follows:

Delete the entry relating to the Church Square Multi-Storey, Scunthorpe

Amend the days and hours of operation for The Parishes, Scunthorpe to read 'All Days, All Hours'.

Add a fifth column entitled 'Tariffs' with tariffs for each Car Park as follows:

Carlton Street - 0-2 hours free, 2-4 hours £2, All Day £3
Deyne Avenue - 0-2 hours free, 2-4 hours £2, All Day £3
Dunstall Street - 0-2 hours free, 2-4 hours £2, All Day £3
High Street East - 0-2 hours free, 2-4 hours £2, All Day £3
King Street/Winterton Road - 0-2 hours free, 2-4 hours £2, All Day £3
King Street (rear of flats) - 0-2 hours free, 2-4 hours £2, All Day £3
Old Courts Road - 0-2 hours free, 2-4 hours £2, All Day £3
The Angel - 0-2 hours free, 2-4 hours £2, All Day £3
Alexandra Road - 0-2 hours free, 2-4 hours £2, All Day £3
Ashby 301 - 0-2 hours free, 2-4 hours £2, All Day £3
Collum Avenue/School Road - 0-2 hours free, 2-4 hours £2, All Day £3
Home Street - 0-2 hours free, 2-4 hours £2.50
Scunthorpe Market - 0-2 hours free, 2-4 hours £2.50
Mary Street Co-Op - 0-2 hours free, 2-4 hours £2.50
Mary Street West - 0-2 hours free, 2-4 hours £2.50
Robert Street - 0-2 hours free, 2-4 hours £2.50
West Street/Chapel Street - 0-2 hours free, 2-4 hours £2.50
Parishes - 0-2 hours free, 2-4 hours £2.50
Bottesford Road - 0-2 hours free, 2-4 hours £2.50
