

**THE NORTH LINCOLNSHIRE BOROUGH COUNCIL**  
**(VARIOUS STREETS) (PROHIBITION AND RESTRICTION OF WAITING**  
**AND STREET PARKING PLACES) (CIVIL ENFORCEMENT AND**  
**CONSOLIDATION) ORDER 2019 (ENDERBY ROAD, SCUNTHORPE AND THE**  
**LINK, ASHBY) (AMENDMENT) ORDER 2025**

North Lincolnshire Borough Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. The North Lincolnshire Borough Council (Various Streets) (Prohibition and Restriction of Waiting and Street Parking Places) (Civil Enforcement and Consolidation) Order 2019 shall be amended in so far as it relates to Scunthorpe and Ashby to the extent described in the Schedule and as shown on drawings numbered YHN5006/24/01/01 Rev A, and YHN5006/23/13/01.
2. This Order shall come into operation on the 4<sup>th</sup> April 2025 and may be cited as The North Lincolnshire Borough Council (Various Streets) (Prohibition and Restriction of Waiting and Street Parking Places) (Civil Enforcement and Consolidation) Order 2019 (Enderby Road, Scunthorpe and The Link, Ashby) (Amendment) Order 2025.

**SCHEDULE**

A – on the western side of Enderby Road (near No 104), Scunthorpe – a restriction of No Stopping Monday-Friday 8am to 4pm on Keep Clear Markings, as shown on drawing YHN5006/24/01/01 Rev A.

B – on the eastern side of Enderby Road (near No 129), Scunthorpe – a restriction of No Stopping Monday-Friday 8.15am to 9.15am and 2.45pm-3.45pm on Keep Clear Markings, as shown on drawing YHN5006/24/01/01 Rev A.

C – at The Link, Ashby, Scunthorpe – a restriction of No Waiting at Any Time, as shown on drawing YHN5006/23/13/01.
