THE NORTH LINCOLNSHIRE BOROUGH COUNCIL (VARIOUS STREETS) (PROHIBITION AND RESTRICTION OF WAITING AND STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2019 (HIGH STREET AND SPRUCE LANE, ULCEBY AND MARKET PLACE, OWSTON FERRY) (AMENDMENT) ORDER 2023

North Lincolnshire Borough Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

- The North Lincolnshire Borough Council (Various Streets) (Prohibition and Restriction of Waiting and Street Parking Places) (Civil Enforcement and Consolidation) Order 2019 shall be amended in so far as it relates to Ulceby and Owston Ferry to the extent described in the Schedule and as shown on drawings numbered YHN5006/23/02/001 and PTI/OF/001 Rev B.
- 2. This Order shall come into operation on the 18th October 2023 and may be cited as The North Lincolnshire Borough Council (Various Streets) (Prohibition and Restriction of Waiting and Street Parking Places) (Civil Enforcement and Consolidation) Order 2019 (High Street and Spruce Lane, Ulceby and Market Place, Owston Ferry) (Amendment) Order 2023.

SCHEDULE

- (A) High Street, Ulceby on the northern side of the Street, outside Stonecroft to designate a disabled parking place for use by general disabled badge holders only as shown on drawing number YHN5006/23/02/001.
 - (B) That section of Spruce Lane, Ulceby alongside 17 Front Street to impose a restriction of no waiting at any time as shown on drawing number YHN5006/23/02/001.
 - (C)Market Place Owston Ferry near its junction with Silver Street to impose a restriction of no waiting at any time as shown on drawing number PFI/OF/001 Rev B .
