## THE NORTH LINCOLNSHIRE BOROUGH COUNCIL (OFF-STREET PARKING PLACES) (CIVIL ENFORCEMENT AND CONSOLIDATION) ORDER 2010 (ELECTRIC VEHICLES CHARGING) (AMENDMENT NO 14) ORDER 2023

North Lincolnshire Borough Council (hereinafter referred to as "the Council") in exercise of its powers under Sections 32 and 35 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984 (hereafter referred to as "the Act of 1984") and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

- The North Lincolnshire Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2010 shall be amended to the extent described in Schedule 1 to this Order.
- This Order shall apply to those Car Parks specified in Schedule 2 to this Order and to the extent described in Schedule 2 to this Order.
- This Order shall come into operation on the 30<sup>th</sup> June 2023 and may be cited as The North Lincolnshire Borough Council (Off-Street Parking Places) (Civil Enforcement and Consolidation) Order 2010 (Electric Vehicles Charging) (Amendment No 14) Order 2023.

## SCHEDULE Amendments

- (A) To add the following Interpretations:
- "electric vehicle" means any vehicle which uses one or more electric motors for propulsion but for the purposes of this Order excludes vehicles that are wholly self-charging (or those that do not have a plug-in charging capability);
- "plug-in hybrid vehicle" means a vehicle that uses an internal combustion engine and one or more electric motors to power it, but for the purposes of this Order excludes vehicles that are wholly self-charging (or those that do not have a plug-in charging capability);
- (B) To add the following to Part 2 of the 2010 Order Designation and Use of Parking Places

No person shall cause or permit a vehicle to be parked in a parking bay marked for electric vehicles unless the vehicle is an electric vehicle or plug-in hybrid vehicle that is being charged. All vehicles using these bays are limited to 4 hours stay with no return within 2 hours Monday to Saturday between 8am-6pm. Outside of these times there is no limit on the length of stay.

(C) To amend the Charging Schedule to the 2010 Consolidation Order to include the following Car Parks in Barton-upon-Humber – Castledyke West, Chapel Lane/Vestry Lane, Cottage Lane and Market Lane – all Long Stay Car Parks.


