

BOROUGH COUNCIL OF WELLINGBOROUGH
(OFF-STREET PARKING PLACES)
(AMENDMENT) ORDER 2013

The Borough Council ("the Council") in exercise of their powers under section 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and after obtaining the consent of the Northamptonshire County Council pursuant to section 39 of the Act and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:

1. This Order shall come into operation on the 1st April 2013 and may be cited as the "Borough Council of Wellingborough (Off-Street Parking Places) (Amendment) Order 2012".
2. The Interpretation Act of 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. In this Order "the Variation Order" means the Borough Council of Wellingborough (Off-Street Parking Places) Variation Order 1994.
4. Except where the context otherwise requires, where an expression is used in this Order which has a meaning assigned to it by virtue of the Consolidation Order the expression has the same meaning as that assigned to it by the Consolidation Order.
5. By this Order the Schedule to the Consolidation Order shall be amended by the addition of the parking place named in column 1 to schedule 1 to this Order and as shown shaded blue on the plan in schedule 2 to this Order which shall be available for the time period specified in column 2 to schedule 1 to this Order. Parking charges, Parking tickets and Season tickets will not be valid for use in the parking places specified in column 1 to schedule 1 and as shown in the plan in schedule 2 to this Order.
6. By this Order, the provisions of the Borough Council of Wellingborough (Off-Street Parking Places) Variation Order 1994 as amended shall remain in force and shall apply to the parking place named in column 1 to schedule 1 of this Order as if the same had been included in the original Consolidation Order with the exception of the provisions of paragraph 5 and 6 of this Order.



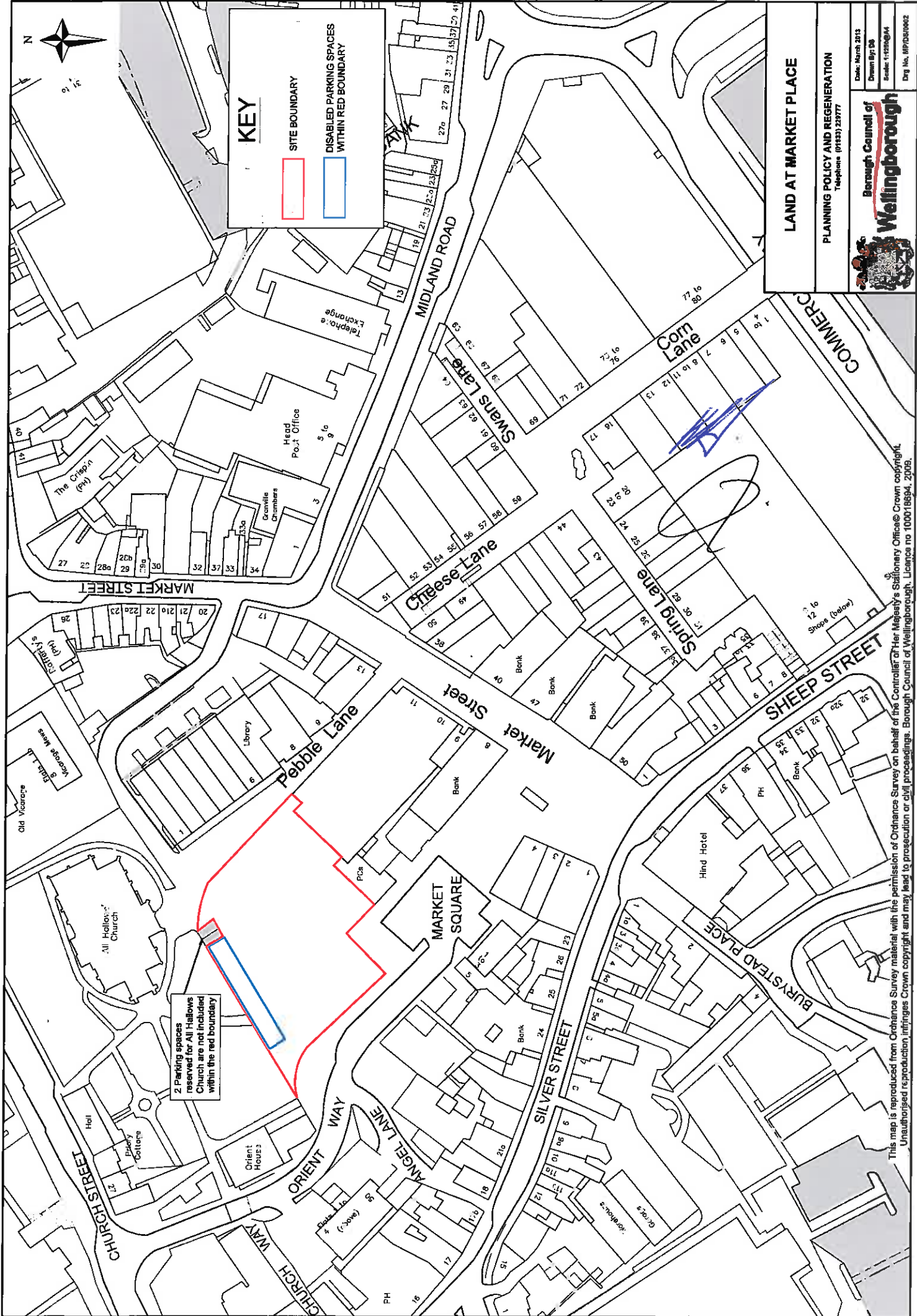
