THE COUNCIL OF THE BOROUGH OF NORTH TYNESIDE (TRAFFIC MOVEMENTS) (CONSOLIDATION) ORDER 2022

The Council of The Borough of North Tyneside ("the Council") in exercise of its powers under Sections 1, 2, 4 and 29 and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, as amended, and of all other enabling powers and after consultation with the Chief Officer of Police, in accordance with Part III of Schedule 9 to the Act, hereby make the following Order:-

<u>PART I</u> GENERAL

Commencement and Citation

1. This Order shall come into operation on the 31 May 2022 and may be cited as The Council of the Borough of North Tyneside (Traffic Movements) (Consolidation) Order 2022.

Revocation

2. The Orders specified in Schedule 1 to this Order are hereby revoked.

Interpretations and Savings

- 3. (1) In this Order the following expressions have the meanings hereby respectively assigned to them:-
 - "The Act of 1984" means the Road Traffic Regulation Act 1984 (as amended);
 - "Bus" has the same meaning as prescribed in the TSRGD 2016 (as amended);
 - "Carriageway" means a way constituting or comprised in a highway being a way (other than a cycle track) over which the public have a right of way for the passage of vehicular traffic;
 - "Goods" means a bulky or valuable object not easily transportable;
 - "Goods vehicle" means a motor vehicle which is constructed or adapted for the carriage or haulage of goods or burden of any description;
 - "Local bus" means a public service vehicle used for the provisions of a local service, not being an excursion or tour;
 - "Local service" has the same meaning as in Section 2 of The Transport Act 1985;
 - "Motor vehicle" means a mechanically propelled vehicle intended or adapted for use on roads;
 - "Pedal cycle" has the same meaning as prescribed in the TSRGD 2016 (as amended);
 - "Taxi" means a vehicle licensed under Section 37 of the Town Police Clauses Act 1847;
 - "TSRGD" means the Traffic Signs Regulations and General Directions 2016 (as amended);
 - "Universal service provider" has the same meaning as in the Postal Services Act 2000;

- (2) Any reference in this Order to the male gender shall be read as applying equally to the female gender.
- (3) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984, or by or under any other enactment.
- (4) In so far as any provision of this order conflicts with any provision which is contained in an Order made or having effect as if made under the Act of 1984, or by or under any other enactment, THEN the provisions of THIS ORDER shall prevail.

PROHIBITION OF MOTOR VEHICLES

4. Save as provided in Article 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any motor vehicles to proceed in a road or section of road specified in Schedule 2 to this Order.

PART III PROHIBITION OF ALL VEHICLES

5. Save as provided in Article 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle except non-mechanically propelled vehicles being pushed by pedestrians to proceed in a road or section of road specified in Schedule 3 to this Order.

PROHIBITION OF ENTRY FOR VEHICULAR TRAFFIC

6. Save as provided in Article 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to proceed in a road or section of road specified in Column 1 of Schedule 5 from a road or section of road specified in Column 2 of the said Schedule.

PART V PLAY STREETS

- 7. Save as provided in Article 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle except non-mechanically propelled vehicles being pushed by pedestrians to proceed between the hours of sunrise and sunset in a road or section of road specified in Part I of Schedule 5 to this Order.
- 8. Save as provided in Article 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle except non-mechanically propelled vehicles being pushed by pedestrians to proceed between the hours of 8.00am and sunset in a road or section of road specified in Part II of Schedule 5 to this Order.

PART VI ONE-WAY RESTRICTIONS

- 9. No person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle to proceed in the road or section of road specified in Column 1 of Schedule 6 to this Order in a direction other than specified, in relation to that road or length of road in Column 2 of the said Schedule.
- No person shall, except upon the direction or with the permission of a police officer in uniform; except when proceeding from one dual carriageway to the other, cause any vehicle to proceed in the dual carriageway of the roads specified in Schedule 7 to this Order, in such direction other than so as to keep the central island or reservation on the right-hand or off side of the vehicle.

PART VII TURNING RESTRICTIONS

- 11. Save as provided in Article 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause or permit any vehicle proceeding in the road or section of road specified in Column 1 of Schedule 8 to this Order, to make a right-hand turn into the road or section of road specified in Column 2 of the said Schedule.
- 12. Save as provided in Article 17 of this Order no person shall, except upon the direction or with the permission of a police officer in uniform, cause any vehicle proceeding in the road or section of road specified in Column 1 of Schedule 9 to this Order, to make a left-hand turn into the road or section of road specified in Column 2 of the said Schedule.
- 13. Save as provided in Article 17 of this Order, all vehicles proceeding in the road or section of road specified in Column 1 of Schedule 10 towards its junction with the road or section of road specified in Column 2 of the said Schedule is required to turn left only into the road or section of road specified in Column 2.
- 14. Save as provided in Article 17 of this Order, no person shall, except upon the direction or with the permission of a police officer in uniform, cause any vehicle proceeding in the road or section of road specified in Column 1 of Schedule 11 to this Order, to make a U-turn in a direction specified in Column 2 of the said Schedule.

PART VIII RIDING OF PEDAL CYCLES PROHIBITED

No person shall ride or cause to be ridden any pedal cycle on the lengths of footpaths, footways or subways specified in Schedule 12 to this Order.

PART IX WEIGHT RESTRICTIONS

16. Save as provided in Article 17 of this Order, no person shall cause or permit any Goods vehicle, which, whether laden or unladen, exceeds 7.5 tonnes to proceed in the roads or lengths of road specified in Schedule 13 to this Order.

PART X EXEMPTIONS

- 17. Nothing in Articles 4 to 16 of this Order shall apply: -
 - (1) to any class of description of vehicles where so specified in relation to a road or length of road in Column 3 of Schedules 2 to 19
 - (2) to any of the following vehicles, where so specified as aforesaid, by reference to this Article: -
 - (a) Any vehicle being used for police, fire brigade or ambulance purposes;
 - (b) Any operational vehicle being used in connection with: -
 - Building or demolition operations in or adjacent land or removal from adjacent land or buildings where the prior written consent of the Council has been received;

- ii. The laying, erection, alteration or repair of sewer pipe or apparatus for the supply of water, gas, electricity or telecommunications apparatus in or on adjacent land;
- iii. The maintenance, improvement or reconstruction of the highway.
- (c) Any vehicle being used in the service of a Universal Service Provider to deliver or collect postal packets as defined in Section 125(1) of the Postal Services Act 2000 to premises situated on or adjacent to the road or length of road named;
- (d) Any vehicle being used in the service of the Council in pursuance of its statutory duties;
- (e) Any local bus;
- (f) Any motor vehicle being used for the purpose of loading or unloading goods to or from any premises situated on or adjacent to the road or length of road named;
- (g) Any pedal cycle;
- (h) A taxi;
- (i) Any vehicle being used by the person requiring access to the premises situated on or adjacent to the road or length of road named;
- (j) Any designated Goods Vehicle being used for the purpose of loading or unloading goods to or from any premises situated on or adjacent to the road or length of road named
