

**THE NORTH LINCOLNSHIRE BOROUGH COUNCIL**  
**(VARIOUS STREETS) (PROHIBITION AND RESTRICTION OF WAITING**  
**AND STREET PARKING PLACES) (CIVIL ENFORCEMENT AND**  
**CONSOLIDATION) ORDER 2019 (VARIOUS STREETS, SCUNTHORPE)**  
**(AMENDMENT) ORDER 2021**

North Lincolnshire Borough Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. The North Lincolnshire Borough Council (Various Streets) (Prohibition and Restriction of Waiting and Street Parking Places) (Civil Enforcement and Consolidation) Order 2019 shall be amended in so far as it relates to Scunthorpe to the extent described in the Schedule and as shown on drawings numbered YHN01117-2020-01, YHN001121-2020-01, YHN05006-20-01 Rev A and YHN05060-001.
2. This Order shall come into operation on the 16<sup>th</sup> July 2021 and may be cited as The North Lincolnshire Borough Council (Various Streets) (Prohibition and Restriction of Waiting and Street Parking Places) (Civil Enforcement and Consolidation) Order 2019 (Various Streets, Scunthorpe) (Amendment) Order 2021.

**SCHEDULE**

- A. Around the junction of Ferry Road, Spencer Avenue and Crosby Avenue – a restriction of No Waiting At Any Time as shown on drawing number YHN01117-2020-01.
- B. Around the junction of Henderson Avenue and Theodore Road – a restriction of No Waiting At Any Time as shown on drawing number YHN01121-2020-01.
- C. Around the junction of Fardell Road and Amos Crescent – a restriction of No Waiting At Any Time as shown on drawing number YHN05006-20-01 Rev A.
- D. West Street, Frances Street and adjacent Tenfoots – restrictions of No Waiting At Any Time, No Waiting Monday-Saturday 9am-6pm and parking limited to 1 hour, no return within 2 hours Monday-Saturday 9am-6pm as shown on drawing YHN05060-001.
