

THE NORTH LINCOLNSHIRE BOROUGH COUNCIL
(VARIOUS STREETS) (PROHIBITION AND RESTRICTION OF WAITING
AND STREET PARKING PLACES) (CIVIL ENFORCEMENT AND
CONSOLIDATION) ORDER 2019 (VARIOUS STREETS,
BROUGHTON, BARTON-UPON-HUMBER, BELTON AND SCUNTHORPE)
(AMENDMENT) ORDER 2022

North Lincolnshire Borough Council in exercise of its powers under Sections 1, 2, 4, 5, 32, 35, 124 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (the Act of 1984) as amended and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby makes the following Order.

1. The North Lincolnshire Borough Council (Various Streets) (Prohibition and Restriction of Waiting and Street Parking Places) (Civil Enforcement and Consolidation) Order 2019 shall be amended in so far as it relates to Broughton, Barton-upon-Humber, Belton and Scunthorpe to the extent described in the Schedule and as shown on drawings numbered YH05006/2122/01/001/ Rev A, YH05006/2122/02/001, YHN5006/2122/06/001 Rev A, YHN5006/21/07/001, YHN5006/03/001/ Rev A and YH05006/21/04/001.
2. This Order shall come into operation on the 24th January 2022 and may be cited as The North Lincolnshire Borough Council (Various Streets) (Prohibition and Restriction of Waiting and Street Parking Places) (Civil Enforcement and Consolidation) Order 2019 (Various Streets, Broughton, Barton-upon-Humber, Belton and Scunthorpe) (Amendment) Order 2022.

SCHEDULE

(A) - around the junction of Greyfriars Road/Brigg Road, Broughton - a restriction of no waiting at any time, and on Brigg Road opposite the School Entrance - a restriction of no waiting Monday-Friday 8am-9am & 3pm-4pm as shown on drawing YH05006/2122/01/001 Rev A.

(B) - around the junction of Appleby Lane/Westminster Road, Broughton - a restriction of no waiting at any time as shown on drawing YH05006/2122/02/001.

(C) - on Pasture Road, Barton-upon-Humber including its junctions with Falkland Way, Nursery Close and Butts Road - no waiting at any time restrictions as shown on drawing YHN5006/2122/06/001 Rev A.

(D) - on the northern side of Holydyke (A1077) Barton-upon-Humber between its junctions with Bowmandale and Vestry Lane - no waiting at any time restrictions as shown on drawing YHN5006/21/07/001.

(E) - on Sandtoft Industrial Estate and around its junction with Sandtoft Road - no waiting at any time restrictions as shown on drawing YHN5006/03/001 Rev A.

(F) - around the junction of Ferry Road/Buckingham Avenue/Buckingham Street North, Scunthorpe - a restriction of no waiting at any time as shown on drawing YH05006/21/04/001.
