1. This Order having been made on the twenty fourth day of June 2003 shall come into operation on the thirtieth day of June 2003 and may be cited as the Northampton Borough Council (Various Areas) (General Traffic Control) (Residents Parking Places) (Amendment No. 10) Order 2003
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The amendments imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or under or by any other enactment.
4. The Northampton Borough Council (Various Areas) (General Traffic Control) (Residents Parking Places) Order 2001 is hereby amended to the extent specified in the Schedule hereto.
