


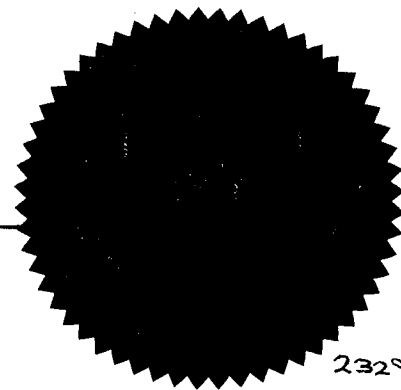

(GENERAL TRAFFIC CONTROL) (AMENDMENT NO 31) ORDER 2003**

Northampton Borough Council pursuant to arrangements made under Section 101 of the Local Government Act 1972 with the Northamptonshire County Council and in exercise of the powers of the said County Council under Sections 1,2,3,4,32,35 and 45 to 53 of the Road Traffic Regulation Act 1984 ("the Act") the Road Traffic Act 1991 Part IV of Schedule 9 to the Act and of all other enabling powers and after consultation with the chief officer of police in accordance with Part III of Schedule 9 to the Act, hereby makes the following Order:-

1. This Order having been made on the twenty fourth day of June 2003 shall come into operation on the thirtieth day of June 2003 and may be cited as the Northampton Borough Council (Various Areas) (General Traffic Control) (Amendment No 31) Order 2003.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The amendments imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made or having effect as if made under the Act or under or by any other enactment.
4. The Northampton Borough Council (Various Areas) (General Traffic Control) Order 2001 is hereby amended to the extent specified in the Schedule hereto.

SCHEDULE

Insert within Schedule 1 to the Order the following figures and words:-

Road	Side	Description
Boughton Green Road	west	from its junction with Isham Close for a distance of 10 metres in a north-easterly direction from its junction with Isham Close for a distance of 10 metres in a south-westerly direction.
Yardley Drive	south-west	from its junction with Boughton Green Road up to 14 metres to the north-west of its junction with Hartwell Close from a point 14 metres south-east of its junction with Upton Close up to 14 metres to the north-west of its junction with Upton Close

Insert a new Article 22(u) to read:-

Save as provided in Articles 23 and 24 of this Order, no person shall cause or permit any vehicle to wait between the hours of 10.00 am to 12.00 noon and 2.00 pm to 4.00 pm Mondays to Fridays inclusive in those lengths of roads specified in Schedule 55 to this Order.

Insert a new Schedule 55 to the Order to read:-

Schedule 55: No waiting Mon-Fri 10am – 12 noon and 2pm – 4pm

Road	Side	Description
Hartwell Close	both	from a point 12 metres west of its junction with Yardley Drive for its entire length in a south-westerly direction
Sutton Close	north-east	from a point 3.7 metres east of its junction with Yardley Drive for a distance of 180 metres in a north-easterly direction.
Sutton Close	south-east	from a point 5.8 metres east of its junction with Yardley Drive for its entire length in a north-easterly direction.
Upton Close	both	from a point 12 metres west of its junction with Yardley Drive for its entire length in a south-westerly direction
