



NORTHAMPTON BOROUGH COUNCIL (OFF STREET PARKING PLACES)
(AMENDMENT No.1) ORDER 2005

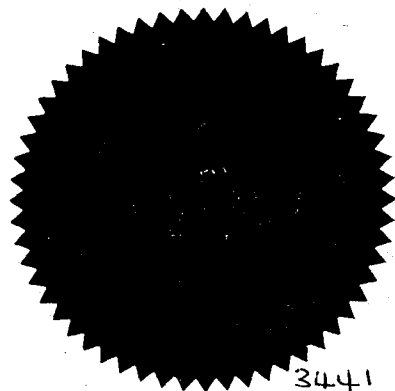
Northampton Borough Council ("the Council") in exercise of its powers under Section 35 (1) and (3) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and the Road Traffic Act 1991 and of all other enabling powers, with the consent of Northamptonshire County Council in accordance with Section 39 (3) of the Act and after consulting the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:-

1. This Order having been made on the twenty first day of February 2005 shall come into operation on the twenty eighth day of February 2005 and may be cited as the Northampton Borough Council (Off-Street Parking Places) (Amendment No.1) Order 2005.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The amendments imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act or under or by any other enactment.
4. The Northampton Borough Council (Off-Street Parking Places) Order 2001 is hereby varied to the extent specified in the Schedule hereto.

Insert within Article 7(6) following the words:- "residents parking ticket shall be valid in the relevant parking places specified in Schedules 2" the following words:- "(except the Mayorhold Multi-Storey)"

Insert within Article 25(1) following the words "not been duly paid" the following words:- "but where the method of payment is Pay on Foot and no ticket indicating the date and time at which the vehicle entered the parking place the charge shall be calculated on the assumption that the vehicle entered the parking place at the time of opening on the same day that the vehicle leaves the parking place"

Insert within Schedule 1 under each heading all existing provisions relating to those car parks known as Abington Place, Albion Place and St Johns Surface currently within Schedule 2 and delete all existing provisions under each heading relating to those car parks from Schedule 2

Delete from Schedule 2 under the heading Scale of Charges in respect of the Mayorhold Multi-Storey the words:- "town centre residents parking ticket available as follows:- 6 months £6.50".

Delete from Schedule 2 under the heading Position In Which Vehicles May Wait in respect of the Mayorhold Multi-Storey the following words:-

"Two wheeled vehicles free to wait within any special bays provided".

Delete from Schedule 2 under the heading "Days of Operation of Parking Place" in respect of the Mayorhold Multi-Storey the following words:- "All days" and insert in substitution therefor the following words:- "All days except Christmas Day".

Delete from Schedule 2 under the heading "Hours of Operation of Parking Place" in respect of the Mayorhold Multi-Storey all existing provisions and insert in substitution therefor the following words:- "Mondays to Saturdays 6.00 am to 8.00 pm; Sundays and Bank Holidays 9.00 am to 6.00 pm".

Delete from Schedule 2 under the heading "Maximum Period for Which Vehicles May Wait" in respect of the Mayorhold Multi-Storey the following words:- "24 hours" and insert in substitution therefor:- "Mondays to Saturdays – 14 hours; Sundays and Bank Holidays – 9 hours"

Delete from Schedule 2 under the heading "Scale of Charges (A Penalty Charge And Reduced Penalty Charge Are Payable)" in respect of the Mayorhold Multi-Storey all references to evening charges, overnight charges and season tickets

Insert within Schedules 1, 2 and 3 a new heading worded as follows:- "Method of Operation"

Insert under the heading "Method of Operation" in respect of that car park known as the Mayorhold Multi-Storey the following words:- "Pay on Foot" and in respect of all other car parks listed under Schedules 1, 2 and 3 insert the words:- "Pay and Display"

Delete all references to the words "Mayorhold Multi-Storey" within the Northampton Borough Council (Off-Street Parking Places) Order 2001 (as amended) and insert in substitution therefor the following words:- "The Mayorhold Shoppers"
