Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Road Traffic Act 1991, and of all other powers enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Road Traffic Act 1991, hereby make the following Order :-

**CITATION AND INTERPRETATION**

1. This Order shall come into operation on the 3<sup>rd</sup> August 2007 and may be cited as "The Northamptonshire County Council (Borough Council of Wellingborough) (Waiting And Loading Restrictions and On-Street Parking Places) Consolidation Order (2007 No. 1577) (Amendment No. 1) Order 2007"
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Borough Council of Wellingborough) (Waiting and Loading Restrictions and On-Street Parking Places) Consolidation Order 2007<sup>(a)</sup>" shall continue in full force and effect subject to :
  - a. the variations to the plan index set out in Schedule 1 to this Order and the incorporation of the plans attached to this Order.
  - b. The following Orders, as set out in Schedule 2 to this Order are hereby revoked:
