(AMENDMENT No. 1) ORDER 2007**

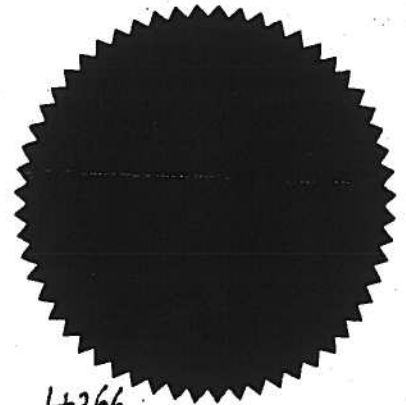
Northampton Borough Council ("the Council") in exercise of its powers under Section 35 (1) and (3) of the Road Traffic Regulation Act 1984 ("the Act") and Part IV of Schedule 9 to the Act and the Road Traffic Act 1991 and of all other enabling powers, with the consent of Northamptonshire County Council in accordance with Section 39 (3) of the Act and after consulting the chief officer of police in accordance with Part III of Schedule 9 to the Act hereby makes the following Order:

1. This Order having been made on the twenty ninth day of October 2007 shall come into operation on the fifth day of November 2007 and may be cited as the Northampton Borough Council (Off-Street Parking Places) (Amendment No. 1) Order 2007.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The amendments imposed by this Order shall be in addition to and not in derogation of any restrictions or requirements imposed by any regulations made, or having effect as if made, under the Act or under or by any other enactment.
4. The Northampton Borough Council (Off-Street Parking Places) Order 2001 is hereby varied to the extent specified in the Schedule hereto.

## SCHEDULE

Insert within Article 6(3) following the words "Mayorhold Shoppers" the following words: "St Johns Multi-Storey and St Michaels Multi-Storey"

Delete from Article 6(5) following the words: "except the "Mayorhold Shoppers" the following words: "where season tickets are not valid)" and insert in substitution therefor the following words: "and St Johns Multi-Storey and St Michaels Multi-Storey (where only annual season tickets are valid)"

Insert within Article 6(5) following the words: "except for the Mayorhold Shoppers" the following words: "St Johns Multi-Storey and St Michaels Multi-Storey where town centre residents parking ticket holders will be issued with a pass card to access a nominated "Pay on Foot" car park"

Delete from Article 7(6) the following words: "and the season ticket shall be valid in the relevant parking places specified in Schedules 2 (except the Mayorhold Shoppers)" and insert in substitution therefor the following words: "and the season ticket shall be valid in the relevant parking places specified in Schedules 2 (except only annual season tickets shall be valid in the Mayorhold Shoppers, St Johns Multi-Storey and St Michaels Multi-Storey)"

Insert within Article 7 (6) following the words: "and the town centre residents parking ticket shall be valid in the relevant parking places specified in Schedules 2 (except the Mayorhold Shoppers" the following words: "St Johns Multi-Storey and St Michaels Multi-Storey where town centre residents parking ticket holders will be issued with a pass card to access a nominated "Pay on Foot" car park)"

Delete from Schedule 2 under the heading "Position In Which Vehicles May Wait" in respect of St Johns Multi-Storey and St Michaels Multi-Storey the following words:

"Two wheeled vehicles free to wait within any special bays provided"

Delete from Schedule 2 under the heading "Days of Operation of Parking Place" in respect of St Johns Multi-Storey and St Michaels Multi-Storey the following words: "All days" and insert in substitution therefor the following words: "All days except Christmas Day"

Delete from Schedule 2 under the heading "Hours of Operation of Parking Place" in respect of the Mayorhold Shoppers and St Michaels Multi-Storey all existing provisions and insert in substitution therefor the following words: "Mondays to Saturdays 7:30 am to 8:00 pm, Sundays 9:00 am to 6:00 pm closed at all other times"

Delete from Schedule 2 under the heading "Hours of Operation of Parking Place" in respect of St Johns Multi-Storey all existing provisions and insert in substitution therefor the following words: "Mondays to Saturdays 7:30 am to 8:00 pm, Sundays 9:00 am to 6:00 pm at all other times customers with an existing parking ticket will be able to exit after the closing times. Season ticket holders and town centre resident permit holders will be able to access this car park at all times"

Delete from Schedule 2 under the heading "Maximum Period for Which Vehicles May Wait" in respect of the Mayorhold Shoppers and St Michaels Multi-Storey all existing provisions

and insert in substitution therefor the following words: "Mondays to Saturdays 12½ hours, Sundays 9 hours"

Delete from Schedule 2 under the heading "Maximum Period for Which Vehicles May Wait" in respect of St Johns Multi-Storey all existing provisions and insert in substitution therefor the following words: "Mondays to Saturdays 12½ hours, Sundays 9 hours but also refer to the provisions under the heading "Hours of Operation of Parking Place" which qualifies these periods for certain customers"

Delete from Schedule 2 under the heading "Scale of Charges (A Penalty Charge and Reduced Penalty Charge Are Payable)" in respect of the Mayorhold Shoppers, St Johns Multi-Storey and St Michaels Multi-Storey all/any references to discounted evening charges, discounted overnight charges, season tickets (save for the charges) and town centre residents parking tickets (save for the charges) and insert in substitution therefor the following words: "Season tickets must be purchased 12 months in advance.

Town centre residents parking tickets

£30 administration fee payable for replacement season ticket pass cards and town centre residents pass cards"

Delete from Schedule 2 under the heading "Method of Operation" in respect of St Johns Multi-Storey and St Michaels Multi-Storey the words "Pay and Display" and insert in substitution therefor the following words: "Pay on Foot"
