THE NORTHAMPTONSHIRE COUNTY COUNCIL (NORTHAMPTON BOROUGH COUNCIL (VARIOUS AREAS) (GENERAL TRAFFIC CONTROL) ORDER 2001) (AMENDMENT No. 14) ORDER 2009

Northamptonshire County Council in exercise of their powers under Sections 1, 2, 32, 35 and 45 to 53 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 of the Act, hereby order as follows: -

- 1. The "Northampton Borough Council (Various Areas) (General Traffic Control) Order 2001" is hereby amended to the extent specified in the Schedule below.
- 2. This Order may be cited as "The Northamptonshire County Council (Northampton Borough Council (Various Areas) (General Traffic Control) Order 2001) (Amendment No.14) Order 2009" and shall come into force on 11th September 2009.



SCHEDULE

- 1. Delete item (b) from Article 10.
- 2. Insert into Article 10:-
 - (b) if a period of less than one hour has elapsed since the termination of the last period of stay (if any) of the vehicle in the same parking place during the parking period (except the parking place in Schedule 62)
 - (c) if a period of less than four hours has elapsed since the termination of the last period of stay (if any) of the vehicle in the same parking place during the parking period (only applies to the parking place in Schedule 62)
- 3. Insert into Article 2 under the definition "permitted hours" (after the list of Schedule numbers) the words:-

"or Schedule 62"

4. Insert into Article 8 (after the list of Schedule numbers) the words:"and Schedule 62"

5. Insert new Schedule 62 as follows:-

Schedule 62 (Waiting limited to 4 hours, 8.00 am - 8.00 pm Monday - Friday)

Kettering Road – west side – from a point 126 metres south of its junction with Abington Grove to a point 63 metres north of its junction with Abington Avenue

6. Insert into Schedule 9 (No waiting 8.00 am – 6.00 pm Monday – Friday):
The Nurseries – both sides including turning heads – entire length

7. Insert into Schedule 1 (Prohibition of waiting):-

Westleigh Close - south side - entire length (including all sides of the turning head)

Ash Street – west – from a point 27 metres south of its junction with Temple Bar to its junction with the turning head

8. Delete from Schedule 1 (Prohibition of waiting):-

Ash Street – west – from its junction with Temple Bar for a distance of 1 metre south

from a point 17 metres south of its junction with Temple Bar to its
junction with the turning head
