**ROAD TRAFFIC REGULATION ACT 1984**

**THE NORTHAMPTONSHIRE COUNTY COUNCIL  
(NORTHAMPTON BOROUGH COUNCIL (VARIOUS AREAS)  
(GENERAL TRAFFIC CONTROL) ORDER 2001)  
(AMENDMENT No. 20) ORDER 2009**

Northamptonshire County Council, in exercise of their powers under Sections 1, 2, 3 and 4 and Schedule 9 of the Road Traffic Regulation Act 1984 and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby makes the following Order :

1. This Order may be cited as "The Northamptonshire County Council (Northampton Borough Council (Various Areas) (General Traffic Control) Order 2001) (Amendment No. 20) Order 2009 and comes into effect on 27<sup>th</sup> July 2009.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. The "Northampton Borough Council (Various Areas) (General Traffic Control) Order 2001" is hereby amended to the extent specified in the Schedules below.

**Schedule A**

The following item is to be revoked from Schedule 56

**Authorised cab rank – Licenced hackney carriages**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Marefair	north	from a point 22.6 metres west of its junction with Horse Market to a point 51.3 metres west of its junction with Horse Market

**Schedule B**

The following item is to be added to schedule 56

**Authorised cab rank – Licenced hackney carriages**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Marefair	north	from a point 74 metres west of the western kerbline of Horse Market westwards for a distance of 13 metres

### **Schedule C**

The following item is to be revoked from Schedule 57

#### **Loading bay – Goods vehicles whilst loading/unloading only**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Marefair	north	from a point 63.3 metres west of its junction with Horse Market to a point 107.5 metres west of its junction with Horse Market

### **Schedule D**

The following new schedule is to be added:-

#### Schedule 61

#### **Loading bay – any vehicle whilst loading/unloading only**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Marefair	south	from a point 6.4 metres east of the eastern kerbline of Freeschool Street eastwards for a distance of 6.8 metres

### **Schedule E**

The following item is to be revoked from Schedule 33

#### **Limited waiting 1 hour Mon – Sat 8am – 6pm**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Marefair	south	from a point 3 metres east of its junction with Freeschool Street for a distance of 14 metres eastwards

### **Schedule F**

The following items are to be revoked from Schedule 1

#### **Prohibition of waiting**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Marefair	north	from a point 107.5 metres west of its junction with Horse Market to its junction with Chalk Lane

**Schedule G**

The following items are to be added to Schedule 1  
**Prohibition of waiting**

<u>Road</u>	<u>Side</u>	<u>Description</u>
Marefair	south	from its junction with Freeschool Street for a distance of 6.4 metres in an easterly direction
Marefair	north	from its junction with Chalk Lane to a point 87 metres west of its junction with Horse Market

**Schedule H**

Insert into Article 8 (after the list of Schedule numbers) the words :-
