A COPY of the Order, together with a plan showing the exact lengths of road to which it relates may be inspected at Irthlingborough Library, High Street, Irthlingborough; Higham Ferrers Library, Midland Road, Higham Ferrers; Rushden Library, Newton Road, Rushden; Raunds Library, High Street, Raunds; Thrapston Library, High Street, Thrapston; and Oundle Library, Glapthorn Road, Oundle during normal opening hours or at the offices of The Traffic Order Section, Riverside House, Bedford Road, Northampton, NN1 5NX during the hours of 9 am to 12 noon and 2 pm to 4 pm on Monday to Friday inclusive.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on the 18th October 2010.
