NOTICE IS HEREBY GIVEN that Northamptonshire County Council have made an Order under Sections 1, 2, 3, 4, 5, 32, 35 to 39 and 45 to 55 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") to introduce the new restrictions and measures as specified in the Schedule below.

A **COPY** of the Order, together with a plan showing the exact lengths of road to which it relates may be inspected at Wellingborough Library, Pebble Lane, Wellingborough during its normal opening hours or at the offices of The Traffic Order Section, Riverside House, Bedford Road, Northampton, NN1 5NX during normal office hours.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on the 5th August 2011.

**(ALL OF THESE ROADS ARE IN THE VICINITY OF
WELLINGBOROUGH RAILWAY STATION)**

1. "Permit holders only" residents parking bays – 9.00am to 12.00pm, Monday to Friday – Dryden Road, Talbot Road (part); Midland Road (part); Senwick Road; Colwell Road; Chester Road; Chace Road; Elsdon Road (part).
2. No waiting at any time – Midland Road (part); Senwick Road (part); Senwick Drive (part).
3. No waiting – 9.00am to 4.00pm, Monday to Saturday – Midland Road (part).
4. Charges for parking permits:–

Residents permit - £25.00 per annum

Temporary residents two month permit – £5.00 (with a maximum of two issued)

Business permit – £250.00 per annum

Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 3, 4, 5, 32, 35 to 39 and 45 to 55 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Traffic Management Act 2004 and of all other powers then enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Traffic Management Act 2004, hereby make the following Order:-

1. This Order shall come into operation on the 5th August 2011 and may be cited as "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009 (Amendment No. 4) Order 2011".
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" shall continue in full force and effect subject to the incorporation of new plans and/or amendments to existing plans identified in Schedule 1 attached to this Order.
3. The charge in connection with the issue of a permit for the leaving of a vehicle in any permit holders parking place shall in respect of a:-
 - (i) residents permit be £25.00 per annum
temporary residents two month permit be £5.00 (with a maximum of two issued)
 - (ii) business permit be £250.00 per annum

There shall be no charge in respect of a visitors permit.

4. The following Article is hereby inserted into "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009"

15. (3) Articles 15(1) and 15(2) shall not apply on Christmas Day, Good Friday and Bank Holidays.


5. Article 28 of "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" is hereby amended to read :-

At all times (with the exception of Christmas Day, Good Friday and Bank Holidays) during which a vehicle is left in a parking place specified in Article 21(8) during the permitted hours, there shall be displayed in the relevant position a permit issued in respect of that vehicle valid for that parking place.

6. In Article 2 of "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" the definition of "permitted hours" is hereby amended to read:-

"permitted hours" means the hours identified on the plans listed in Schedule 1 attached to this Order and/or set out in Schedule 2 to this Order, except that in respect of visitors permits "permitted hours" means the hours identified on the permit.
