NOTICE IS HEREBY GIVEN that Northamptonshire County Council have made an Order under Sections 1, 2, 3, 4, 5, 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 to introduce waiting restrictions as specified in the Schedule below.

A COPY of the Order, together with a plan showing the exact lengths of road to which it relates may be inspected at Corby Library, The Links, Queen's Square, Corby during its normal opening hours or at the offices of The Traffic Order Section, Riverside House, Bedford Road, Northampton, NN1 5NX during the hours of 9 am to 12 noon and 2 pm to 4 pm on Monday to Friday inclusive.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on the 22nd of July 2011.

SCHEDULE

(Prohibition of waiting)

Courier Road - northern leg - both sides - from Phoenix Parkway to the west of Cockerell Road

Courier Road - western leg - both sides - at its junction with the northern leg

Courier Road – western leg – east side – from a point approximately 95 metres south of the northern leg for a distance of approximately 125 metres south

Courier Road – southern leg – both sides – from the eastern leg to the western leg (including the turning head) except for an approximate 70 metre section on the north side

Courier Road - eastern leg - both sides - entire length

Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 3, 4, 5, 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Traffic Management Act 2004 and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Traffic Management Act 2004, hereby make the following Order:-

- This Order shall come into operation on the 22nd July 2011 and may be cited as "The Northamptonshire County Council (Corby District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009 (Amendment No. 3) Order 2011".
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Corby District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" shall continue in full force and effect subject to the incorporation of the amendments detailed on the plans identified in Schedule 1 attached to this Order.
