- This Order shall come into operation on the 24th February 2012 and may be cited as "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009 (Amendment No. 6) Order 2012".
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" shall continue in full force and effect subject to the incorporation of new plans and/or amendments to existing plans identified in Schedule 1 attached to this Order.

NOTICE IS HEREBY GIVEN that Northamptonshire County Council have made an Order under Sections 1, 2, 3, 4, 5, 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 to amend the existing waiting restrictions in Sheep Street and Silver Street, Wellingborough as specified in the Schedule below.

A COPY of the Order, together with a plan showing the exact lengths of road to which it relates may be inspected at Wellingborough Library, Pebble Lane, Wellingborough during its normal opening hours or at the offices of The Traffic Order Section, Riverside House, Bedford Road, Northampton, NN1 5NX during the hours of 9 am to 12 noon and 2 pm to 4 pm on Monday to Friday inclusive.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on the 24th of February 2012.
