(WAITING AND LOADING RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2009 (AMENDMENT No. 2) ORDER 2010

Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 3, 4, 5, 32 and 35 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Traffic Management Act 2004 and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Traffic Management Act 2004, hereby make the following Order:-

- This Order shall come into operation on the 24th September 2010 and may be cited as "The Northamptonshire County Council (Corby District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009 (Amendment No. 2) Order 2010".
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Corby District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" shall continue in full force and effect subject to the incorporation of the amendments detailed on the plans identified in Schedule 1 attached to this Order and the incorporation of the amendments to the existing Articles as follows:
 - a) In Article 6, after the word "wait" insert the words "or stop"
 - b) In Article 7, after the words "any vehicle to wait" insert the words "(except on entrance zig-zag markings during the specified times)"
 - c) Amend Article 8 (1) (a) to read:- "a person to board or alight from the vehicle (except on entrance zig-zag markings during the specified times)"
 - d) Insert the following definition into Article 2:- "entrance zig-zag markings" means an area of carriageway which is comprised within and indicated by road markings complying with diagram 1027.1 in Schedule 6 to the 2002 Regulations
