

- This Order shall come into operation on the 25th May 2012 and may be cited as "The Northamptonshire County Council (South Northamptonshire District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009 (Amendment No. 2) Order 2012".
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (South Northamptonshire District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" shall continue in full force and effect subject to the incorporation of new plans and/or amendments to existing plans identified in Schedule 1 attached to this Order.

NOTICE IS HEREBY GIVEN that Northamptonshire County Council have made an Order under Sections 1, 2, 3, 4 and 5 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") to amend "The Northamptonshire County Council (South Northamptonshire District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" as specified in the schedule below.

A COPY of the Order, together with a plan showing the exact lengths of roads to which it relates and a statement of the Council's reasons for making the Order, may be inspected at Towcester Library, Richmond Road, Towcester during normal opening times or at Riverside House, Riverside Way, Bedford Road, Northampton during normal office hours.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on 25th May 2012.
