THE NORTHAMPTONSHIRE COUNTY COUNCIL (VARIOUS ROADS, NORTHAMPTON) (WAITING AND LOADING RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2011 (AMENDMENT No. 6) ORDER 2011

Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 3, 4, 5, 32, 35 to 39 and 45 to 55 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended, and the Traffic Management Act 2004 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

- This Order shall come into operation on the 30th September 2011 and may be cited as "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011 (Amendment No. 6) Order 2011".
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" shall continue in full force and effect subject to the incorporation of the amendments detailed on the plans identified in Schedule 1 attached to this Order.
- Insert into Schedule 2 of "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" underneath "Permit Charges" the words:-

Visitor permit - no charge

- 4. Delete from Article 2 of "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" the meaning of "business permit holder".
- 5. Insert into Article 2 of "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" the following meaning:-

"hours" in respect of the hours of operation of permit holders parking places means the hours identified on the plans listed in Schedule 1 attached to this Order, except that with respect to business permits in zone F, "hours" means the period between 8.00 am and 10.00 pm Mondays to Saturdays inclusive, and with respect to business permits in all other zones "hours" means the period between 8.30 am and 4.30 pm Mondays to Saturdays inclusive, and with respect to visitors permits in zone F, "hours" means the period between 10.00 am and 10.00 pm Mondays to Saturdays inclusive, and with respect to visitors permits in all other zones "hours" means the period between 10.00 am and 6.00 pm Mondays to Saturdays inclusive, in all cases any such day not being Christmas Day, Good Friday or a Bank Holiday being a public holiday.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on the 30th of September 2011.
