
Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 3, 4, 5, 32, 35 to 39 and 45 to 55 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended, and the Traffic Management Act 2004 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

1. This Order shall come into operation on the 15th October 2012 and may be cited as "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011 (Amendment No. 12) Order 2012".
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" shall continue in full force and effect subject to the incorporation of the amendments detailed in this Order and on the plans identified in Schedule 1 attached to this Order.
3. In Article 2 of "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" the meaning of "hours" is hereby amended to read:-

"hours" in respect of the hours of operation of permit holders parking places means the hours identified on the plans listed in Schedule 1 attached to this Order, any such day not being Christmas Day, Good Friday or a Bank Holiday being a public holiday.
4. Article 21 (5) (b) of "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" is hereby revoked.
5. Article 27 (a) of "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" is hereby amended to read:-

- (a) the registration mark of the vehicle or vehicles in respect of which the permit has been issued (except business permits)

NOTICE IS HEREBY GIVEN that Northamptonshire County Council have made an Order under Sections 1, 2, 3, 4, 5, 32, 35 to 39 and 45 to 55 and Schedule 9 of the Road Traffic Regulation Act 1984 to amend "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" as specified in the Schedule below.

A COPY of the Order, together with a plan showing the exact lengths of road to which it relates may be inspected at Northamptonshire Central Library, Abington Street, Northampton or St James Library, St James Road, Northampton during its normal opening hours or at the offices of The Traffic Order Section, Riverside House, Bedford Road, Northampton, NN1 5NX during normal office hours.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on the 15th of October 2012.

SCHEDULE

CHANGES TO PERIOD OF OPERATION OF PERMIT HOLDERS ZONES

ALL PERMITS (RESIDENT / BUSINESS / VISITOR) TO OPERATE FOR THE FULL HOURS OF EACH ZONE (ZONES A,B,C,D,E,F,G)

PERMIT ZONE "A" (Billing) – Change from 8am – 6pm, Mon – Sat to 24 hours a day, Mon – Sat.

PERMIT ZONE "C" (Victoria Gardens) – Change from 8am – 6pm, Mon – Sat to 24 hours a day, all week.

PERMIT ZONE "F" (St James) – Change from 8am – 10pm, Mon – Sat to 24 hours a day, all week.

PERMIT ZONE "G" (Spring Boroughs) – Change from 8am – 6pm, Mon – Sat to 24 hours a day, all week.

OTHER CHANGES

PERMIT ZONE "A" (BILLING)

1. All existing limited waiting bays within the zone (except for those specified in paragraphs 2 and 3 below) to be changed to dual-use bays (2 hours limited waiting, 8am – 10pm, Mon – Sat – or permit holders only 24 hours, Mon – Sat).
2. St Edmund's Road – all limited waiting bays to be changed to 1 hour, 8am – 6pm, Mon – Sat.

3. Denmark Road / Victoria Road / Cyril Street / Palmerston Road – 2 no. limited waiting bays on each road (nearest to Billing Road) to be changed to 1 hour, 8am – 6pm, Mon – Sat.
4. Woodford Street – existing double yellow lines to be changed to dual-use bay (as specified in paragraph 1 above) – north side – adjacent to property number 61, Palmerston Road.
5. Woodford Street – existing limited waiting bay to be changed to permit holders only bay – south side – opposite property number 15, Ethel Street.
6. Ethel Street – existing double yellow lines to be changed to permit holders only bay – Ethel Street – west side – adjacent to property numbers 14 – 16.
7. Various Roads – existing single yellow lines to be changed to double yellow lines:- Palmerston Road (between St Edmunds Road and Woodford Street); Ethel Street; Edith Street – east side – near property number 9; Cyril Street; Victoria Road – east side – between property number 72 and the limited waiting bay; Victoria Road – west side – adjacent to property number 67 and also between property number 69A and the limited waiting bay; Thenford Street – both sides – adjacent to property numbers 17 to 21; Alexandra Road – west side – between property numbers 36 and 1A (Billing Road).

PERMIT ZONE “C” (VICTORIA GARDENS)

1. Victoria Gardens – existing double yellow lines to be changed to permit holders only bay – south side – opposite property numbers 32 and 34.
2. Victoria Gardens – single yellow lines to be changed to double yellow lines – south side – opposite property number 10 and also around the bend and north side – around the bend.
3. Victoria Gardens – single yellow lines to be changed to permit holders only bay – west side – adjacent to property number 15, Victoria Promenade and east side – adjacent to property number 16, Victoria Promenade.

PERMIT ZONE “D” (ALCOMBE ROAD)

1. Spencer Road – single yellow lines to be changed to double yellow lines except the last two sections nearest Kettering Road which are to be changed from 8am – 10pm, Mon – Sat to 8am – 6pm, Mon – Sat.
2. Various Roads – single yellow lines to be changed from 8am – 10pm, Mon – Sat to 8am – 6pm, Mon – Sat – Queen’s Road; Grove Road; Somerset Street; Overstone Road; Dunster Street.
3. Alcombe Road north side – opposite the Church – double yellow lines to be changed to single yellow lines 8am – 6pm, Mon – Sat.

PERMIT ZONE “E” (THE MOUNTS)

1. Robert Street – north side – between William Street and Connaught Street – loading bay to be changed to permit holders bay.
2. Earl Street – east side – adjacent to property number 76 – double yellow lines to be changed to limited waiting bay.
3. Duke Street – south side – between property numbers 71 and 73 – single yellow lines to be changed to double yellow lines / permit holders bay.
4. Louise Road – south side – adjacent to property numbers 31 to 37 – double yellow lines to be changed to limited waiting bay.
5. Earl Street – east side – south of property number 74 and south of property number 100; Margaret Street – east side – adjacent to property numbers 13 to 19; Cranstoun Street – both sides at the northern end and both sides adjacent to property numbers 18 to 20 and 17 to 19 – double yellow lines to be changed to permit holders bay.

PERMIT ZONE “F” (ST JAMES)

1. Various roads – double yellow lines to be removed – Sharman Road – both sides – near its junction with St James' Road; south side – near its junction with Lincoln Road; Lincoln Road – east side – north of Sharman Road; west side – near the junction of Sharman Road and south of its junction with Spencer Street; Spencer Street – north side – near its junction with Lincoln Road.
2. Various roads – double yellow lines to be changed to permit holders bay – Sharman Road – north side – adjacent to property numbers 11 and 13; Spencer Street – south side – adjacent to property numbers 24 and 26; Abbey Street – north side – adjacent to property numbers 70 and 72; Melbourne Road – north-west side – each end.
3. Spencer Street – north side – loading bay to be removed.
4. Various roads – limited waiting bays to be changed to 2 hour limited waiting, 8am – 10pm and permit holders only 10pm – 8am – Bowden Road; Abbey Street; Melbourne Road; Sandhill Road – eastern end; Bruce Street – southern end; Dundee Street – north side, western end; Elgin Street – both sides, western end.
5. Sandhill Road – western end – 2 hour limited waiting bay to be changed to 3 hours limited waiting, 8am – 10pm and permit holders only 10pm – 8am.
6. Various roads – new waiting bays, 2 hours, 8am – 10pm and permit holders only, 10pm – 8am – Argyle Street – southern end and south side – opposite property numbers 5 – 13; Dundee Street – north side, eastern end and south side, western end; Elgin Street – south side, eastern end; Forfar Street – south side, western end; Glasgow Street – northern end, east side.
7. Bruce Street – north side – opposite property numbers 51 – 57 – new waiting bay, unrestricted 8am – 6pm and permit holders only 6pm – 8am.
8. Glasgow Street – new loading only bay – Mon – Sat, 7am – 6pm and permit holders only all other times.

PERMIT ZONE "G" (SPRING BOROUGH)

1. Cromwell Street – limited waiting bays to be changed to permit holders bays.
2. Compton Street – south side – single yellow line to be changed to unrestricted parking.
3. Monks Pond Street / Spring Lane / Crispin Street / Scarletwell Street – new unrestricted parking.
4. Lower Bath Street – western end – double yellow lines to be changed to unrestricted parking.
5. Upper Bath Street – each end – double yellow lines to be changed to permit holders bays.
