Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 3, 4, 5, 32, 35 to 39 and 45 to 55 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended, and the Traffic Management Act 2004 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

1. This Order shall come into operation on the 17th May 2013 and may be cited as "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011 (Amendment No. 11) Order 2013".
2. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" shall continue in full force and effect subject to the incorporation of the amendments detailed on the plans identified in Schedule 1 attached to this Order.

NOTICE IS HEREBY GIVEN that Northamptonshire County Council have made an Order under Sections 1, 2, 3, 4, 5, 32, 35 to 39 and 45 to 55 and Schedule 9 of the Road Traffic Regulation Act 1984 to amend "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2011" as specified in the Schedule below.

A COPY of the Order, together with a plan showing the exact lengths of road to which it relates may be inspected at Northamptonshire Central Library, Abington Street, Northampton or at Moulton Library, Doves Lane, Moulton during its normal opening hours or at the offices of The Traffic Order Section, Riverside House, Bedford Road, Northampton during normal office hours.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on the 17th of May 2013.

SCHEDULE

DOUBLE YELLOW LINES

Lodge Way – both sides – from the end of the double yellow lines near Harlestone Road for a further 30 metres; Lower Farm Road / Owl Close junction – west side; Owl Close – south-west side and around the turning head; Lower Farm Road – both sides – at its junction with Red House Road roundabout; Lower Farm Road / Lower Farm Place junction – north side; Lower Farm Place – both sides; Lower Farm Road / Tenter Road junction – south side; Lower Farm Road – at all accesses and on both sides around the bend; Tenter Road – entire length; Lower Farm Road / Boarden Close junction; Boarden Close – around the turning head; Lower Farm Road – west side – between Boarden Close and Red House Road; Lower Farm Road / Red House Road junction.

1 HOUR LIMITED WAITING, 8AM – 6PM, MON - SAT

Lower Farm Road – east side – between Boarden Close and Red House Road.

EXISTING NO WAITING 8AM – 6PM, MON – SAT CHANGED TO

1 HOUR LIMITED WAITING, 8AM – 6PM, MON - SAT

Adelaide Street – both sides.

Denmark Road – both sides – adjacent to property numbers 7 and 8, Billing Road.
