THE NORTHAMPTONSHIRE COUNTY COUNCIL (WELLINGBOROUGH DISTRICT) (WAITING AND LOADING RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2009 (AMENDMENT No. 8) ORDER 2013

Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 3, 4, 5, 32, 35 to 39 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended and the Traffic Management Act 2004 and of all other powers them enabling and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and with the Traffic Management Act 2004, hereby make the following Order:-

- This Order shall come into operation on the 24th May 2013 and may be cited as "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009 (Amendment No. 8) Order 2013".
- Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" shall continue in full force and effect subject to the incorporation of new plans and/or amendments to existing plans identified in Schedule 1 attached to this Order.
- Schedule 2 of "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" is hereby revoked.
- Article 6 of "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" is hereby amended to read "Article 6 (a)".
- Insert into "The Northamptonshire County Council (Wellingborough District) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2009" the following new Article:-
 - 6 (b) Save as provided in Articles 7 to 12 of this Order no person shall, except upon the direction or with the permission of a police constable in uniform or authorised officer, cause or permit any goods vehicle exceeding the maximum gross weight identified on the plans listed in Schedule 1 attached to this Order to wait or stop (if specified), for the periods specified, on the roads or sides of the roads, or on the verges or footways, identified on the plans listed in Schedule 1 attached to this Order.

NOTICE IS HEREBY GIVEN that Northamptonshire County Council have made an Order under Sections 1, 2, 3, 4, 5, 32, 35 to 39 and Schedule 9 of the Road Traffic Regulation Act 1984. The general effect of the Order is to amend the waiting restrictions as specified in the Schedule below.

A COPY of the Order, together with a plan showing the exact lengths of road to which it relates may be inspected at Wellingborough Library, Pebble Lane, Wellingborough during its normal opening hours or at the offices of The Traffic Order Section, Riverside House, Bedford Road, Northampton during normal office hours.

If you wish to question the validity of the Order or of any provisions contained in it on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984, or on the grounds that any requirement of that Act, or of any instrument made under it has not been complied with in relation to the Order, you may, within six weeks from the date of this Notice apply to the High Court for this purpose.

This Order will become effective on the 24th of May 2013.

DOUBLE YELLOW LINES (Wellingborough)

Shaw Close – both sides – entire length; Davy Close – both sides – entire length; Rutherford Drive – both sides – between Sywell Road and a point 250 metres south of that junction; Rutherford Drive / Huxley Close junction (except east side of Rutherford Drive); Huxley Close – north side – between a point 43 metres west of Rutherford Drive and a point 115 metres west of that junction; Huxley Close – south side – between its junction with Rutherford Drive and a point 90 metres west of that junction.

PROHIBITION OF WAITING OF GOODS VEHICLES EXCEEDING 5 TONNES MAXIMUM GROSS WEIGHT

Holcot Lane, Sywell - west side - lay-by located 130 metres north of Overstone Road

EXISTING LOADING ONLY, MON – SAT, 7.00 am – 7.00 pm CHANGED TO LOADING ONLY, 7.00 am – 7.00 pm AND NO STOPPING EXCEPT TAXIS, 7.00 pm – 7.00 am

Silver Street, Wellingborough - south side - adjacent to property numbers 1 - 4.

EXISTING LOADING ONLY, 7.00 am - 7.00 pm AND NO WAITING EXCEPT TAXIS, 7.00 pm - 7.00 am CHANGED TO LOADING ONLY, 7.00 am - 7.00 pm AND NO STOPPING EXCEPT TAXIS, 7.00 pm - 7.00 am

Silver Street, Wellingborough – south side – adjacent to property numbers 4A – 5A.

EXISTING LOADING ONLY CHANGED TO LOADING ONLY, 6.00 am - 6.00 pm (20 MINUTES MAXIMUM LIMIT)

Market Street, Wellingborough – east side – adjacent to property numbers 30 – 32; west side – adjacent to property number 26.

EXISTING DOUBLE YELLOW LINES CHANGED TO 1 HOUR LIMITED WAITING, MON – SAT, 8am – 6pm AND NO STOPPING 6 pm – 6 am EXCEPT TAXIS

Church Street, Wellingborough - north side - lay-by adjacent to property number 17.
