THE NORTHAMPTONSHIRE COUNTY COUNCIL (VARIOUS ROADS, NORTHAMPTON) (WAITING AND LOADING RESTRICTIONS AND ON-STREET PARKING PLACES) (CONSOLIDATION) ORDER 2018 (AMENDMENT No. 1) ORDER 2018

Northamptonshire County Council (hereinafter referred to as "the Council") in exercise of the powers conferred by Sections 1, 2, 3, 4, 5, 32, 35 to 39 and 45 to 55 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), as amended, and the Traffic Management Act 2004 and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984, hereby make the following Order:-

- Article 1. This Order shall come into operation on the 26th November 2018 and may be cited as "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2018 (Amendment No.1) Order 2018".
- Article 2. In Part 1 (Citation and Interpretation), Article 2 of the "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2018" the following meanings are inserted;

"private hire vehicle" has the same meaning as in section 80 of 'The Local Government (Miscellaneous Provisions) Act 1976'.

"taxi's" has the same meaning as "Hackney carriage" and explicitly does not include Private Hire Vehicles.

"taxi rank" has the same meaning as "Hackney Stand" and explicitly does not include Private Hire Vehicles.

Article 3. In Part 1 (Citation and Interpretation), Article 2 of the "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2018" the meaning of "Hackney Carriage" and "Hackney Stand" is amended to read;

"hackney carriage" means a vehicle licenced under section 37 of the Town and Police Clauses Act 1847, Section 6 of the Metropolitan Carriages Act 1869, or any similar enactment. The definition of a hackney carriage does not include, or make provision for Private Hire Vehicles.

"hackney stand" means an area of carriageway which is comprised within and indicated by road markings complying with diagram 1028.2 or 1028.5 in Schedule 7, Part 4 to the 2016 Regulations. Where restrictions apply, a stand for use by hackney carriages does not include, or make provision for use of Private Hire Vehicles.

- Article 4. In Article 14 of the "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2018" the wording is hereby amended to read;
 - 14. Save as provided in Articles 7, 8 and 20 and/or identified in the plans listed in Schedule 1 attached to this Order a parking place is described as available for vehicles of a specified class or in a specified position and the driver of a vehicle shall not permit it to wait or stop (if specified) in that parking place:-
 - (a) unless it is of the class identified on the plans listed in Schedule 1 attached to this Order; or
 - (b) in a position other than that identified on the plans listed in Schedule 1 attached to this Order.
- Article 5. In Article 27 (a) of the "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2018" the wording is hereby amended to read;
 - (a) the registration mark where required of the vehicle or vehicles in respect of which the permit has been issued.
- Article 6. Without prejudice to the validity of anything done or to any liability incurred in respect of any act or omission before the coming into operation of this Order, "The Northamptonshire County Council (Various Roads, Northampton) (Waiting and Loading Restrictions and On-Street Parking Places) (Consolidation) Order 2018" shall continue in full force and effect subject to the incorporation of the amendments detailed on the plans identified in Schedule 1 attached to this Order.
