#### 1. Commencement and Citation

This Order shall come into operation on the 3<sup>rd</sup> May 2016 and may be cited as "Northumberland County Council North Northumberland Area (Northern) (Parking Places) Composite Order 2011 - Amendment No 8 Order 2016".

"Order" means "Northumberland County Council North Northumberland Area (Northern) (Parking Places) Composite Order 2011".

"Amendment Order" means "NCC North Northumberland Area (Northern) (Parking Places) Composite Order 2011 - Amendment Order No 8 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.




