Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45 and 46 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:

1. Commencement and Citation

This Order shall come into operation on the 3rd May 2016 and may be cited as "Northumberland County Council North Northumberland Area (Northern) (Parking Places) Composite Order 2011 – Amendment No 8 Order 2016".

2. In the Order:-

"Order" means "Northumberland County Council North Northumberland Area (Northern) (Parking Places) Composite Order 2011".

"Amendment Order" means "NCC North Northumberland Area (Northern) (Parking Places) Composite Order 2011 – Amendment Order No 8 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions





The Orders have been considered necessary to enable the removal a small section of No Waiting at Any Time restriction (Double Yellow Lines) and replace with Limited Waiting Parking bays on Golf Club Road Berwick upon Tweed and in order to provide some additional parking spaces in the area, this may be utilised throughout the day by different users i.e. limited waiting parking spaces.
