Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

**1. Commencement and Citation**

This Order shall come into operation on the 22<sup>nd</sup> September 2014 and may be cited as "Northumberland County Council West Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 17 Order 2014".

**2. In the Order:-**

"Order" means "Northumberland County Council West Northumberland Area (Waiting and Loading) Composite Order 2011

"Amendment Order" means "Northumberland County Council West Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 17 Order 2014".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

**STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDER**

*1) The provision of 'a 'Resident Permit Parking Zone' on Circle Place and 'No Waiting at Any Time' restriction on Haugh Lane in Hexham.*

Key issues

- 1) The current 'No Waiting Every Day between 9am and 6pm' restriction causes parking difficulties for residents of Circle Place.
- 2) The gap in the existing 'No Waiting at Any Time' restrictions on Haugh Lane causes congestion.
