#### 1. **Commencement and Citation**

This Order shall come into operation on the 8th June 2015 and may be cited as "West Northumberland Area (Waiting and Loading) Composite Order 2011 -Amendment No 23 Order 2015"

#### 2. In the Order:-

"Order" means "Northumberland County Council West Northumberland Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "NCC West Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 23 Order 2015".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

(Referenced in this Amendment Order as: The Schedule - DELETIONS)


