Northumberland County Council North Northumberland (Southern) Area (Parking Places) Composite Order 2011- Amendment No 6 Order 2014

Made: 15th September 2014.
Coming into operation: 22nd September 2014

Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45, 46, 49 and 51 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:

1. Commencement and Citation

This Order shall come into operation on the 22nd September 2014 and may be cited as "Northumberland County Council North Northumberland (Southern) Area (Parking Places) Composite Order 2011- Amendment No 6 Order 2014".

2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Southern) Area (Parking Places) Composite Order 2011".

"Amendment Order" means "Northumberland County Council North Northumberland (Southern) Area (Parking Places) Composite Order 2011- Amendment No 6 Order 2014".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions
