Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the ~~1 June~~ ^{9 June} 2014 and may be cited as "Northumberland County Council South East Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 21 Order 2014".

2. Amendments to Existing Orders

(a) The Orders specified in the First Schedule are amended in the following way:

- (i) PART II – WAITING, LOADING AND UNLOADING AND STOPPING RESTRICTIONS Section 1 – Restrictions

8. Loading Bays

Save as provided in Articles 15 and 18 of this Order, no person, except upon the direction or permission of a police constable in uniform or a traffic warden, shall cause or permit any Vehicle to wait on any Loading Bay during the Permitted Hours except a Vehicle whilst Goods are being continuously loaded or unloaded from the Vehicle or are being delivered or collected from premises.

Will be deleted and replaced with:

- (ii) PART II – WAITING, LOADING AND UNLOADING AND STOPPING RESTRICTIONS Section 1 – Restrictions

8. Loading Bays

Save as provided in Articles 15 of this Order, no person, except upon the direction or permission of a police constable in uniform or Civil Parking Enforcement Officer, shall cause or permit any Vehicle to wait on any Loading Bay during the Permitted Hours except a Vehicle whilst Goods are being continuously loaded or unloaded from the Vehicle or are being delivered or collected from premises.
