Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

### **1. Commencement and Citation**

This Order shall come into operation on the 1<sup>st</sup> September 2015 and may be cited as "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011 – Amendment No 27 Order 2015".

### **2. In the Order:-**

"Order" means "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011"

"Amendment Order" means "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011 – Amendment No 27 Order 2015".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

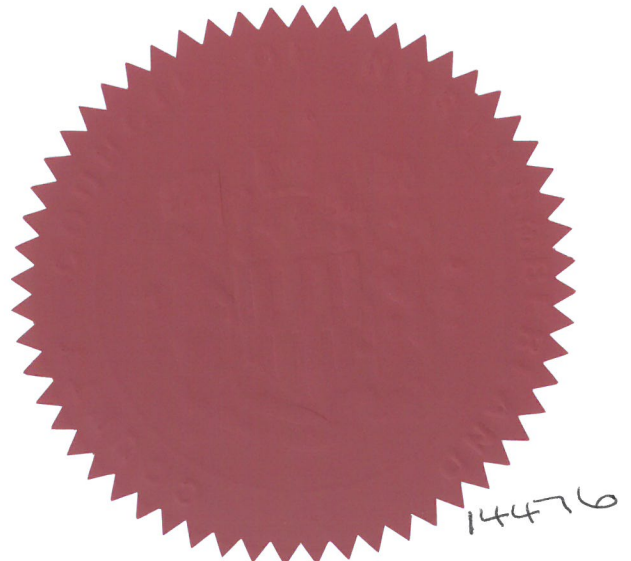

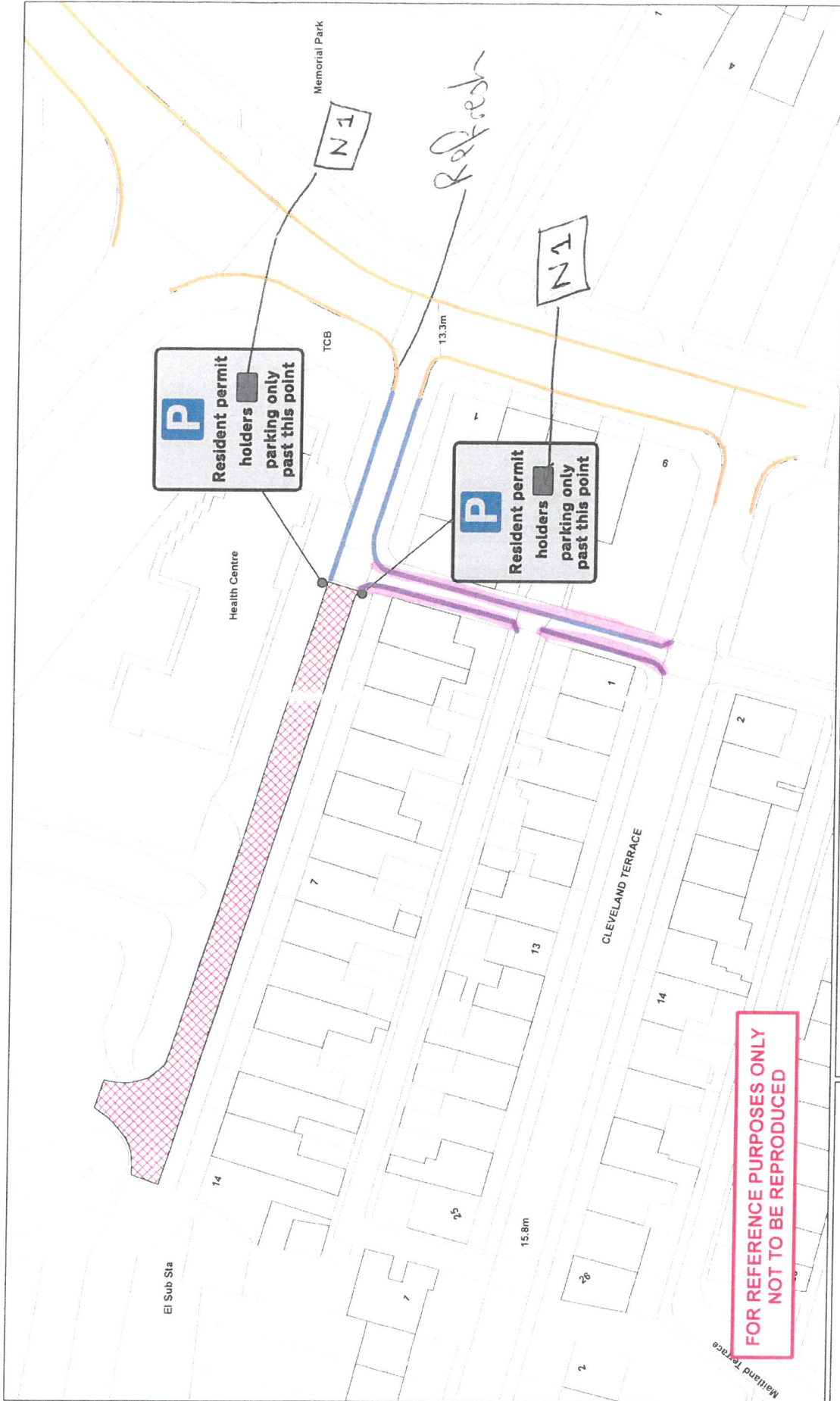

**STATEMENT OF THE COUNCIL'S REASONS FOR  
MAKING THE ORDER**

The Order is for the provision to amend and introduce a small number of waiting restrictions and to introduce a Resident Parking Zone (RPZ) on the Buteland Terrace Area of Newbiggin-by-the-Sea. Thereby, allowing enforcement against indiscriminate parking and to aid traffic flow in this area.
