#### 1. Commencement and Citation

This Order shall come into operation on the 8<sup>th</sup> September 2015 and may be cited as "Northumberland County Council (Off Street Parking Places) Composite Order 2014 - Amendment No 3 Order 2015".

## STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDER

The Order is for the provision of additional "Off Street Parking Places" in Alnwick, Amble, Blyth and Hexham. This will require an amendment to NCC Off Street Parking Places Composite Order 2014. These additional car parks have been identified by the Parish/Town Councils and local stakeholders arising from both the impact of free parking in Northumberland and increased demand for parking spaces.
