1. Commencement and Citation

"Amendment Order" means "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011 - Amendment No7 Order 2013".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.
