Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 6th October 2014 and may be cited as "Northumberland County Council North Northumberland (Central) Area (Waiting and Loading) Composite Order 2011- Amendment No 8 Order 2014".

2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Central) Area (Waiting and Loading) Composite Order 2011"

"Amendment Order" means "North Northumberland (Central) Area (Waiting and Loading) Composite Order 2011- Amendment No 8 Order 2014".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be; additions to, deletions from, or substitutions in the restrictions in the Order:

(A) Additions

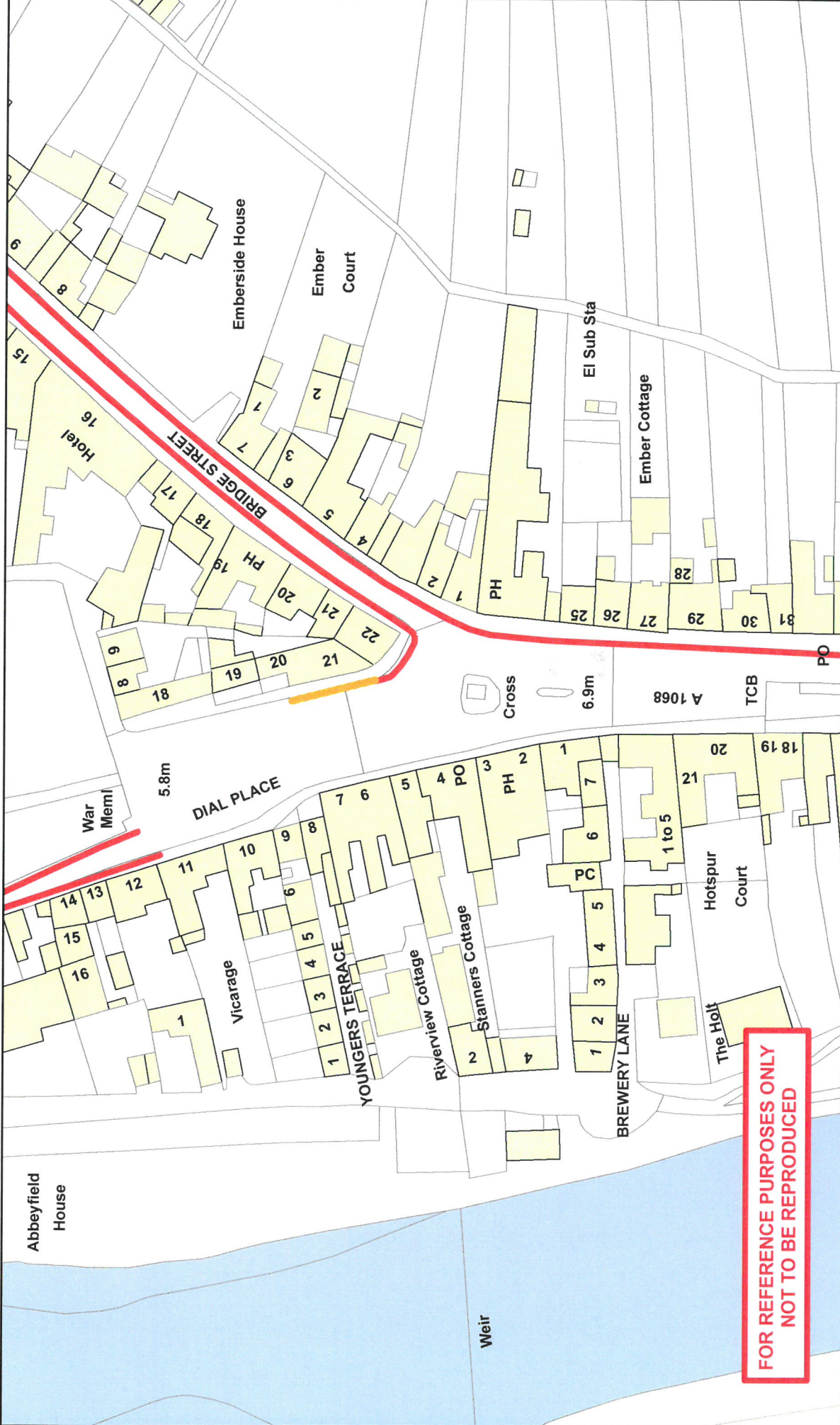
STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDER

'NO WAITING AT ANY TIME' RESTRICTION – DIAL PLACE - WARKWORTH

*The provision of 'No Waiting at Any Time Restriction Extension –
Dial Place Warkworth'*

Key issues

- 1) Parking bays are obstructed by car parking on the opposite side of the road.
An extension of the existing restriction will alleviate this issue.
