1. **Commencement and Citation**

"Amendment Order" means "NCC North Northumberland (Northern) Area (Parking Places) Composite Order 2011 - Amendment No 7 Order 2015".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.



STATEMENT OF THE COUNCILS REASONS FOR MAKING THE ORDER

The Order is for the introduction of Resident Parking Places on a section of Town Close High Newton.. Thereby, allowing enforcement against indiscriminate parking, provide parking places for residents and to aid traffic flow in this area.
