Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 20th October 2014 to remain in force until the 19th October 2015 and may be cited as "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011 – Amendment No 11 Order 2014– Experimental Order".

2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011

"Amendment Order" means "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011 – Amendment No 11 Order 2014– Experimental Order".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

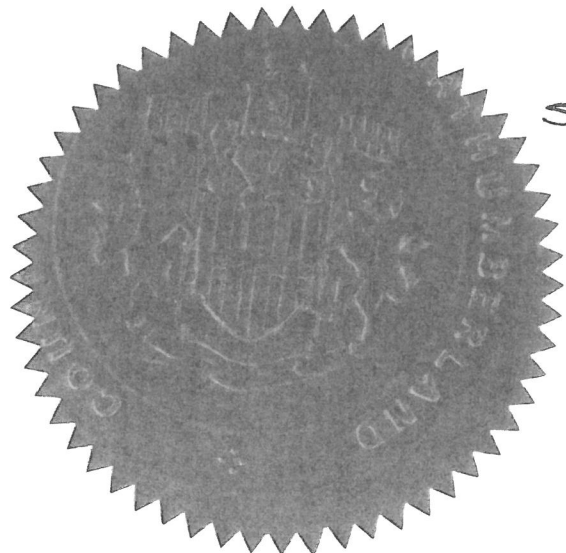

STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDER

1) The experimental restoration of short term parking on Marygate in Berwick-upon-Tweed

Key issues

- 1) Marygate was semi-pedestrianised in 2005 as part of the Berwick Town Centre Improvement Programme, which resulted in the loss of short term parking
- 2) Residents and visitors to Berwick have identified a need to restore short term parking to stimulate business use in the area.
