Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 1st March 2017 and may be cited as "South East Northumberland Area (Waiting and Loading) Composite Order 2011 Amendment No 56 Order 2017".

2. In the Order:-

"Order" means "South East Northumberland Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "NCC South East Northumberland Area (Waiting and Loading) Composite Order 2011 Amendment No 56 Order 2017".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

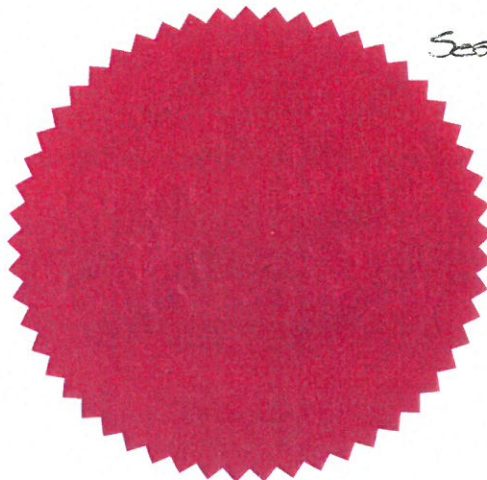

Order 2011- Amendment No 17 Order 2015 - Experimental Order

The general effect of the Order will be to will be to introduce a number of No Waiting and Loading Restrictions on Nairn Road, Newlyn Drive and Needham Place Cramlington and to introduce a Resident Parking Zone (CM3) in Nairn Road Cramlington.
