Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 14th August 2017 and may be cited as "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011 - Amendment No 61 Order 2017".

2. In the Order:-

"Order" means "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011- Amendment No 61 Order 2017".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

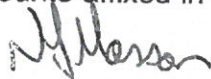

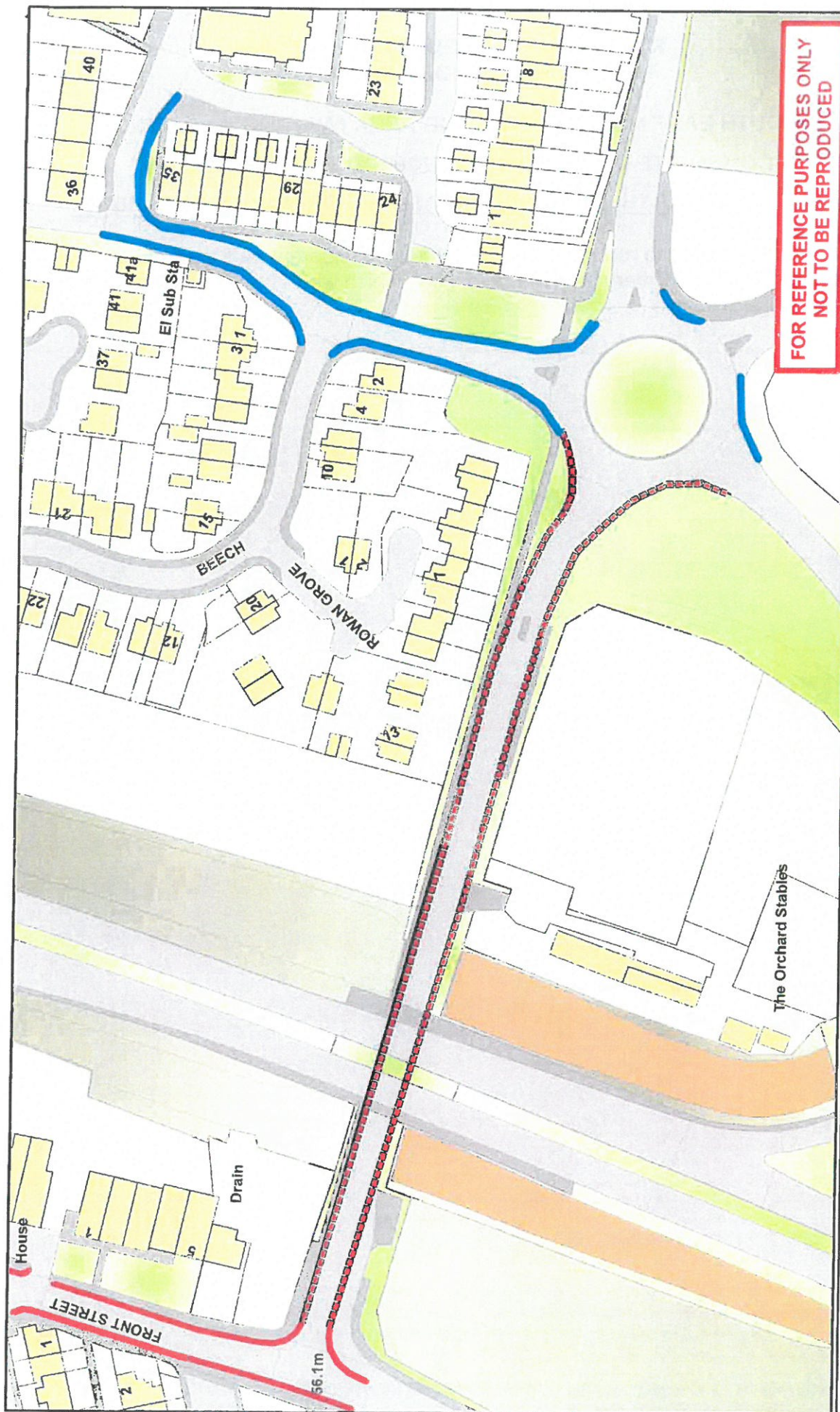
