 NOTICE IS HEREBY GIVEN that the Northumberland County Council have made the above-named Orders under Sections 1, 2, 4, 32, 35, 45, 46 and paragraphs 20 and 27 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Orders, which will come into force on the 21st November 2016 will be to introduce Blue Badge Holders Parking Places, Time Limited Parking Places and No Loading to the new street layout on Station Road in Ashington.

The following restrictions are revoked from the Principal Order, South East Northumberland Area (Parking Places) Composite Order 2011 (TRO_012):-

Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 21st November 2016 and may be cited as "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011 - Amendment No 50 Order 2016".

2. In the Order:-

"Order" means "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011- Amendment No 50 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

**STATEMENT OF THE COUNCILS REASONS FOR
MAKING THE ORDER**

The Order is necessary to introduce A Restricted Parking Zone on Station Road to prevent vehicles from parking except in authorised bays.
