Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45, 46 and Part IV of Schedule 9 of the Road Traffic Regulation 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 21st November 2016 and may be cited as "Northumberland County Council South East Northumberland Area (Parking Places) Composite Order 2011 - Amendment No 18 Order 2016".

2. In the Order:-

"Order" means "Northumberland County Council South East Northumberland Area (Parking Places) Composite Order 2011".

"Amendment Order" means "Northumberland County Council South East Northumberland Area (Parking Places) Composite Order 2011- Amendment No 18 Order 2016".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:

(A) Additions

to Schedule 2 – Limited Waiting Parking Places

 NOTICE IS HEREBY GIVEN that the Northumberland County Council have made the above-named Orders under Sections 1, 2, 4, 32, 35, 45, 46 and paragraphs 20 and 27 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Orders, which will come into force on the 21st November 2016 will be to introduce Blue Badge Holders Parking Places, Time Limited Parking Places and No Loading to the new street layout on Station Road in Ashington.

If you wish to question the validity of the Orders or any of the provisions contained therein on the grounds that they are not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or any instrument made under them have not been complied with in relation to the Orders you may before the 31st December 2016 apply to the High Court for that purpose.
